Item One: Mr. Michael Ehling, Executive Administrator presenting the Mental Health Community Service Award. He explained that every year this award is presented to someone who has made a contribution to advancing mental health in the community. He stated that this year the award is given to Mr. Ron Albertini. Mr. Ehling stated that Mr. Albertini served on the Mental Health Governing Board for over 25 years and was instrumental in advancing the purchase of the land in Frontenac as a nature preserve and invested a lot of time and energy in creating the trails and mapping out the preserve. Mr. Ehling presented the award to Mr. Albertini's widow, Ms. Willa Albertini. Ms. Albertini thanked Mr. Ehling and stated that Ron really wanted to help out with the preserve and always wanted to help the community. Ms. Albertini introduced her family members that were present, her sister Ms. Reta Fuqua and her daughter Ms. Heather Albertini. Commissioner Moody stated that he worked with Ron in different aspects of the county for over 25 years and that Ron was wonderful to work with and everything he did for Crawford County was greatly appreciated. Commissioner Johnson and County Counselor Jim Emerson both expressed what a great guy Ron was to work with.
