Item Six: Commissioner Moody thanked Jill Warford with EMS for attending the work session this morning, and for explaining ambulance billing. Commissioner Moody also requested an update from Commissioner Wood about CTEC. Commissioner Wood explained that he attended his first meeting since rejoining the board. He gave an update on the CDL program and overall operations of CTEC. He was pleased with how things are going.

Item Seven: Commissioner Wood gave an update on some surveyor equipment that has been broken. The commissioners as a whole approved the purchase of replacement equipment. Commissioner Wood also requested a copy of a county cell phone reimbursement list.

Item One: County Counselor Jim Emerson provided a legislative update. He stated that SB 162 (nuisance bill) did not get worked and is passed on until next year and SB 248 (sales tax bill) was amended to include eliminating both the state and local sales tax on groceries. All commissioners expressed their disappointment as the county and local municipalities will lose a lot of revenue.

Item Two: Mr. Emerson presented the commissioners a copy of the opioid settlement agreement. Mr. Emerson recommended that the commission approve the agreement.
