# UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE PUBLIC

**Item One:** Mr. Michael Swan addressed the Commissioners and discussed a situation with his daughter Meadowlark Elementary and testing positive for COVID-19. He stated his concerns with the quarantines, isolations and false positive tests. Commissioner Moody stated that he understands Mr. Swan's concerns.

**Item Two:** Mr. Brian Hanson addressed the Commissioners with concerns with quarantines, isolations and false positives. He discussed doctors and nurses working while COVID positive and actively sick with symptoms. Mr. Hanson stated that the Commissioners are supervisors of the County Health Officer and the Health Department and the Commissioners have legal authority over the Health Officer. He also stated that the Commissioners have the ability to override anything the Health Officer does in his role as County Health Officer. Mr. Hanson said that anything the County Health officer does is with the Commissioners' blessing including quarantines and isolations. Mr. Hanson discussed setting up a disbursement fund through the County to cover lost wages due to quarantines and isolation periods. He referenced K.S.A. 65-301 and read the statute to the Commissioners. Commissioner Moody stated he understands the situation but at this point the Commissioners' hands are tied. Commissioner Blair explained situations and problems with school staffing. Commissioner Blair said he was willing to listen to ideas to improve the situation, but that he has friends die of Covid in the last two months and wants to keep everyone safe. Commissioner Blair stated he is in contact with area superintendents and with the help of the health department, everyone is trying to keep schools open.

**Item Three:** Ms. Jenna Stout addressed the Commissioners and stated that she is one of a few parents that won't play the game because their kids can't play the game. Ms. Stout's 10-year-old son addressed the Commissioners and stated that he cannot wear a mask because he cannot breathe with one on, so now he cannot go to school.

**Item Four:** Ms. Lexi Cronister addressed the Commissioners and stated that her mother's name is Kari Kennard Cronister and her dad is Keith Cronister. Lexi stated that she is now homeschooled due to all the rules, regulations and mandates. She stated that she chose not to attend public school in Crawford County and now does not have to worry about masks or quarantines. She feels that now she is getting a quality education in her home instead of attending public school.

Mr. Hanson stated that Mr. Stout and Ms. Croninster are two examples of children that cannot be in the school system right now and he believes there are many more children

with the same situation. He said that results in Crawford County and the school districts missing out on those dollars.

County Counselor Jim Emerson addressed contact tracing and stated that it is no longer being done. He also stated that there are other statutes that the County is required to follow besides K.S.A. 65-301 and there are statutes the County is required to follow regarding isolation and quarantine guidelines. He said that he believes that quarantines are on the verge of being done.
