Item One: Opening of Rock Bids. County Clerk Lisa Lusker opened the bid from Mulberry Limestone and County Counselor Jim Emerson read the bid aloud. He stated that the bid included the Kansas Department of Agriculture Weights & Measures Division scale certifications. Ms. Lusker opened the bid from Midwest Minerals and Mr. Emerson read the bid aloud and stated that they also included their scale certifications. The Commissioners decided to pass the bids on to Triad Engineering for recommendations.

Item One: Mr. Brannon Green, AssuredPartners addressed the Commissioners in referencing to property, casualty and work comp insurance. He gave some information on his company and stated he is here today to introduce himself and his company and to answer any insurance the Commissioners have. Mr. Green explained that AssuredPartners will be a consultant and help the County manage and make good, educated decisions on the insurance buying process. He stated he wants to give the County the best options. He explained that he would like to do an analysis of the County's current policies and show their capabilities and to see if they can offer something better than what the county is now getting. There was a discussion on changing brokers. The Commissioners stated that they will discuss this and will contact Mr. Green if they have any additional questions.

NEW BUSINESS

Item One: Ms. Lusker presented a letter including an invoice for the 2023 Southeast Kanas Regional Planning Commissioner dues in the amount of \$8,245.80. She stated that in the letter it states that grant writing services are offered to member counties at no charge. Mr. Emerson explained that with the county being members, every city in the county has access to SEKRPC services and they have been helpful in obtaining grants for some of the cities. Commissioner Wood stated that he was on the board when he was a commissioner 4 years ago and stated that he was not impressed. Ms. Lusker explained that the dues are \$2,400 plus \$.15 per capita and the dues only change with population. The Commissioners asked that Ms. Lusker contact the cities and see if they have utilized the services of SEKRPC and also contact SEKRPC to see if a representative can attend a Commission meeting.

Item Two: Ms. Lusker presented the Commissioners with the funding requests for Parks & Recreation, Elderly, Historical and Special Alcohol funds for their review. The Commissioners will schedule a work session to go over the requests.

Item Three: Mr. Emerson stated that he would like to schedule a work session with IT Director Brandon Spaur and a representative from PayClock to discuss the time clock program at 9:30 AM on January 31, 2023. The Commissioners agreed.

Item Four: Mr. Emerson presented an ARPA draw down request for January 2023. He explained the requests included in the draw down. There was a discussion on the large child care ARPA funding. Commissioner Wood would like to review the requests before approving. The Commissioner will readdress this issue on Tuesday.

Item Five: Commissioner Blair presented a letter from the Board of County Commissioners to Mr. Ron Scripsick, Chairman of Point Forward in reference to ARPA funding. He explained that this letter was requested by Harmony/Point Forward to show the amount of funds allocated to them through ARPA funding.

Item Six: Commissioner Wood said that the barricades have been received and Emergency Management department will mark them as Crawford County's property and they will be stored at the Freeto Building out of the weather.
