

CRAWFORD COUNTY BOARD OF HEALTH PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE PUBLIC

Item One: Mr. John Kida, Account Executive from Unique Paving Materials, regarding their Ravel Check Asphalt Rejuvenating Liquid. Mr. Kida stated that their product can be used on top of asphalt or chip & seal to penetrate the surface and fill in the tiny cracks that develop as the surface ages. The liquid reintroduces some of the elements of the asphalt that are lost over time and it then seals it all into the surface for a period of 3 to 5 years. There was a discussion of the ingredients in this product as well as the pricing and shipping terms for the product.

Mr. Kida stated that his company will be demonstrating their product on some roads in the El Dorado and Augusta areas in the next couple of weeks and he would like to have some people from Crawford County come out and observe the process and see how the road looks after the product is applied. The Commissioners asked about a small demonstration of the product in Crawford County and Mr. Kida stated that he would try to put together a demo that could be used to invite other county and city officials to. Mr. Kida was going to correspond with Randy Chiartano about some of these possibilities.
