MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: County Health Officer Ms. Teddi Van Kam addressed the Commissioners with a COVID-19 update. The Commissioners received the Crawford County Gating Criteria updated 7/9/2021. She stated that the County is back in the red due to the increase in new cases. She went through the gating criteria. She explained that so far this week there are 69 new cases and that is not including today and tomorrow's outcome and there were already new cases coming in this morning. She stated that there has been an increase in testing this week and there have been 5 deaths in the last 10 days. She addressed the Delta Variant and stated that it is not more virulent but is a lot more transmissible and it is in Crawford County. She explained that the Delta Variant is spreading through the unvaccinated individuals and the deaths have been unvaccinated or partially vaccinated people. Commissioner Moody was answered that Crawford County is at 50% of the population being vaccinated and there are people still coming in to get vaccinated through the Health Department, Community Health and the pharmacies. Ms. Van Kam stated that she would like to make a plea today to those people in the county that are unvaccinated to really think about it and this is because as health care providers, they care about people and want to be able to help them. She stated that none of the Health Care workers want to see anymore deaths. Commissioner Moody asked if the Commissioners can help in any way and Ms. Van Kam stated that possibly the Commissioners could state their support of vaccinations as vaccinating is the only thing that can make a change and the only recourse the health officials have. Commissioner Blair stated that those who don't believe in the vaccine need to live accordingly and try to protect others. Commissioner Blair asked about the symptoms of the Delta Variant and Ms. Van Kam stated that the symptoms are about the same and a lot of people complain of allergy symptoms and others have GI effects. She stated that if people are having these symptoms, get tested and to call the Health Department and arrangements will be made to be tested and it is a very simple process. She stated that CHC, hospitals and urgent cares are also testing. Ms. Van Kam stated that Ascension Via Christi has 9 positive admissions with 1 on a ventilator and Girard Medical Center has 1 positive admission and both hospitals are giving the antibody infusions. Commissioner Moody was answered that if a

person is vaccinated or have had the natural disease they do not have to quarantine if they come into contact with a positive case. She explained that they have had some breakthrough cases but those cases are having very mild symptoms and not being hospitalized and if you have been vaccinated and are having symptoms you need to be tested. Commissioner Blair was answered that Ms. Van Kam feels that the Health Department is adequately staffed but she is looking into additional contact tracers. Ms. Van Kam stated that she will attend the Commission meeting next week for an update.
