The following public comments were heard: Dr. Jim Triplett, Chairman of the Crawford County Solid Waste Planning Committee discussed how the regional solid waste authority was dissolved and Crawford County needs to update their county plan so that they could remain eligible for some grant funding. He stated that the planning committee met and went through the plan and made made some revisions. He said that the SEK Recycling Center helps the county to remain in compliance with a lot of KDHE rules in this area. Dr. Triplett stated that he believes the updated plan is ready to be submitted to KDHE for approval. He explained that once the plan is approved, grants will then be available for application. Dr. Triplett discussed some grants he believes would be beneficial. He also discussed some of the different programs offered by the recycling center. There was a discussion of the landfill. Dr. Triplett discussed the large item drop-off program through the recycling center and their work with the City of Pittsburg and Pittsburg State University for storage options for some of the large item drop offs.

Residential/Commercial recycling has improved from an estimated 2% in 1992 to an estimated 5.4% in 2017.

3. What is the current recycling and/or diversion rate? How was this determined?

The current recycle rate (RR, based on 2017 values) appears to be about 5.4 %. The documented tonnage of materials recycled materials (R) divided by average per person rate of 4.7 pounds of disposed waste in Kansas (supplied by KDHE) multiplied by the County population (D) plus the recycled tonnage (R).

$$RR = R / (D+R) * 100.$$

Oak Grove Landfill has – ±13 years left based on current information from the landfill operator. (216,000 MM Btu in 2012 Gas recovered from waste in 2017.)

The Committee goals for the next 10-year period include the following:

1. Increase public participation in the waste reduction program.
2. Quantify commercial and industrial recycling more accurately.
3. Prepare, in a timeframe sufficient for Commissioner approval, a budget sufficient to accomplish the coming year's solid waste management goals.
4. Use County or State financial input to promote public service activities such as the tire amnesty program.
5. Use city water bills to advertise waste management goals and alternatives.
6. Review SEKR recycling efforts and ways the Committee can assist.
7. Continue the successful e-waste collection program.
8. Encourage the household hazardous waste program serving the County and its expansion into nearby counties.
9. Review the degree of illegal dumping in the County.
10. Encouragement of programs for commercial corrugated paper recycling, especially among retail and manufacturing sectors.
11. Encourage, support, and add stability for County recycling programs for residential and commercial sources.
12. Periodically review landfill activities throughout the County for compliance with KDHE regulations and County agreements.
13. Expand current HHW services to include wastes from Small Quantity Hazardous Waste Generators.
14. Review the need for rural collection beyond that currently available.
15. Review Crawford County Solid Waste Plan

2012 Update (Prepared 2013)

Section A

Has the population of your county increased or decreased significantly since your original plan was written? Explain, and if so, how has this affected solid waste management in the county?

The 2010 US census listed the population of Crawford County at 39,134, the 2000 census listed it at 38,242. This is an increase of 892 persons, or about 2.3%. The County population has increased 10% (1990 – 35,568 vs. 2010 – 39,134) since the plan was developed. The Kansas population is projected to increase slowly for the next years. The privately owned municipal solid waste landfill (Oak Grove, Permit No. 741) located in the County is obligated by contract to guarantee disposal of the waste generated in the Crawford County for a period of 25 years after the commencement of operations at the facility, i.e. CY 2019.

What was the disposal practice for waste generated within the County when your original plan was written? Has this changed, and if so, what is your current method of disposal?

1994 – Original Plan

The County was served by one privately owned Subtitle D landfill in 2001 (Oak Grove Landfill, Permit No. 741) operated by Deffenbaugh Industries. Eight private haulers provided collection and transporting services. Kansas Department of Health & Environment (KDHE) listed six construction/demolition landfills, two waste tire monofill/transporter/processor (Champlin Tire Recycling, Inc. and Southeast Kansas C & D Landfill), and one solid waste transfer station (Lloyds Loads Permit No. 770). Used oil was collected from the public by three KDHE listed processors or collection centers – Red Giant Oil, Southwest Oil, and Safety Kleen. The County is also served by a publicly subsidized, non-profit recycling program (CCCR) open three days a week. Metals were accumulated and recycled by Commercial Metals Company and Frontenac Aluminum, both located in Frontenac.

2012

The Subtitle D landfill located in the County has been operated by Waste Corporation of Kansas, Inc. since 2002. Eight private haulers provide collection and transporting services. Kansas Department of Health & Environment (KDHE) lists three construction/demolition landfills, two waste tire monofills/transporters/processors (Southeast Kansas C & D and Champlin Tire Recycling), and two solid waste transfer station (Lloyds Loads and SEKR, Pittsburg, Kansas). Used oil is collected from the public by several automotive-oriented retail businesses. These businesses are contracted to management companies (such as Safety Kleen in Springfield, MO). The County is also served by a publicly subsidized, non-profit recycling program, Southeast Kansas Recycling (SEKR, formerly CCCR) open five days a week. Metals, glass, newspaper, clothing, plastic, cardboard, used oil, car batteries, rechargeable batteries, mercury thermostats, used motor oil, latex paint, cell phones, used cooking oil are all accepted by SEKR.

In 2007, the City of Frontenac allows private enterprise residential and commercial trash service and has enacted an ordinance regarding residential and industrial storage of solid waste, hours of collection, and licensing of haulers within the City.

The City of Walnut has made trash collection a franchised, city utility. Green Environmental collects MSW from each active residence in Walnut with the fees paid to the City as part of the water bill. The City contracts with Green Environmental for service.

The City of Arcadia allows private enterprise residential and commercial trash service and provides an annual two week waste collection service, aimed at large items, for city residents. These efforts have been well received by the public.

The City of Arma allows private enterprise residential and commercial trash service and has passed an ordinance prohibiting MSW collection via alleys.

The City of Cherokee allows private enterprise residential and commercial trash service.

The City of Pittsburg and Crawford County provide a one-day-a-month large item collection event at SEKR to remove these items from the general waste stream. This is an effort to reduce orphaned waste in the city\County.

Recycling opportunities / programs In 2012, the Committee was aware of one used oil processor (Red Giant Oil) and several retail facilities collecting used oil from customers, one metal recycler, and a publicly subsidized, privately operated (SEKR) recycling facility for the County. SEKR accepts mixed papers, glass, metals, corrugated cardboard, plastic, clothing, pallets, and white goods. As estimated by SEKR administrators, the amount removed by their operations from the waste stream in CY 2000, CY 2007, and CY 2012 was about as follows:

Crawford County has taken the lead in establishing a multi-county Household Hazardous Waste Coop to better manage HHW in southeast Kansas. The facility, to be managed by SEKR with Crawford County as the formal operating entity, opened in CY 2010. Results have not met expectations to this point, however Crawford County has increased its direct support of the HHW program by subsidizing the first \$10,000 of disposal costs in 2013; and it is anticipated that this will increase management of waste paint, used oil, pesticides, herbicides, etc. The Committee will review the future of this program and possibly expansion depending on the success of this initial effort. Crawford County arranged for initial HHW training and purchased satellite storage cabinets for other interested counties as part of a cooperative HHW program, however due to economic issues, this program has yet to expand to additional counties. Crawford County and SEKR have also established an e-waste recycling facility managed by SEKR to be

The County listed two **waste tire** monofills in 2002. In 2012, one (Champlin) remains with no new facilities listed. The County Solid Waste Planning Committee is considering another tire amnesty event to remove waste tires from the area; however such an event will be contingent on KDHE\County funding.

White goods recycling is currently carried out by commercial operations and by SEKR in the County. No changes in the management of these wastes have been contemplated by the Committee.

Large, bulky waste items such as couches, chairs, tables, mattresses, box springs, and appliances are accepted at the SEKRI facility each 2nd Saturday of each month. This service is provided by Crawford County, the City of Pittsburg, and SEKRI.

The two largest cities have taken the lead relating to **yard waste** and **brush and tree** management in the County. These wastes are still accepted at the area landfills. The City of Pittsburg also allows limited public access to their open burning facility for disposal of limbs and trees.

No significant changes by the County have been made in the management of **industrial wastes** since the plan was written.

No significant changes have been made in the management of **medical wastes** since the plan was written. The landfill located in the County accepts limited medical wastes on a special waste (KDHE approved) basis. No "red bag" wastes are accepted. Wastes are currently handled by out of area contract services.

What are the County's recycling and/or diversion goals, if any?

- Expand the current County HHW program to remove substantial quantities of HHW from the waste streams in Crawford County and surrounding counties.
- Expand the e-waste collection/recycling facility in the County.
- Continued support (financial and through public awareness) of the current recycling efforts.
- Encouragement, documentation, and assistance of new and existing recycling programs in the County by the private business sector to continue to reduce waste streams at the source of generation.

Were benchmark measurements of recycling and/or diversion taken when planning began? If so, what was the recycling and/or diversion rate at that time?

A rate of about 17% recycling of waste materials (about 2,900 tons of 17,300 tons generated) was determined for industrial entities in the County in 1992. No data has been generated to indicate this assumption has changed.

The residential and non-manufacturing commercial recycling rate was determined to be about 2% (about 520 tons of an estimated 27,500 tons generated) at the time of the original plan (1993).

What is the current residential recycling and/or diversion rate? How was it determined?

The recycling rate (RR) for residential and non-manufacturing commercial applications in 2012 was about 3.8% (1,621 tons recycled of an estimated 43,037 tons generated) in CY 2012. This does not reflect most commercial recycling operations such as used oil, cardboard, cooking oil, and metals. The documented tonnage of materials recycled materials (R) divided by average per person rate of 5.8 pounds

4. Use County or State financial input to promote public service activities such as the tire amnesty program.
5. Possible use of city water bills to advertise waste management goals and alternatives.
6. Review SEKR recycling efforts and ways the Committee can assist.
7. Continue the successful e-waste collection program.
8. Encourage the household hazardous waste program serving the County and its expansion into nearby counties.
9. Review the degree of illegal dumping in the County.
10. Encouragement of programs for commercial corrugated paper recycling, especially among retail and manufacturing sectors.
11. Encourage, support, and add stability for County recycling programs for residential and commercial sources.
12. Periodically review landfill activities throughout the County for compliance with KDHE regulations and County agreements.
13. Expand current HHW services to include wastes from Small Quantity Hazardous Waste Generators.
14. Explore future of in-county municipal solid waste disposal options.
15. Review the need for rural collection beyond that currently available.

- Pre-blast surveys will be available to the neighboring homes.


