UNDER THE HEADING NEW BUSINESS

PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH MESSAGES FROM THE PUBLIC

Item One: Mr. Jay Humbard addressed the Commissioners and stated that he is the developer of Prairie View Estates. Mr. Humbard stated that he could not attend the previous commission meeting because of his travel schedule for work. He said that all of the lots in this development have already been sold and that all of the buyers are making plans to build nice homes in that area that will only enhance the property values in that area. He explained that he could understand the concerns of the other area residents but he assured the Commissioners that all of the homes built in this development will be stick-built homes and the new home owners that intend to take control of the HOA and make sure that this development is taken care of. Mr. Humbard stated that he intends to build the road to county specifications so that the HOA would have the option to transfer that road to the county in the future. The Commissioners discussed their concerns about this development and that the HOA agreement is being redrafted to address some of those concerns.

Mr. Eric Schieffelbein spoke on behalf of eight of the purchasers of the lots in the proposed development. Mr. Schieffelbein stated that his group intends to build nice homes in this development and to make sure that the HOA is active in keeping this a nice neighborhood to raise their families.

Commissioner Moody asked Troy Graham, Zoning Administrator to contact the citizens that had concerns about this development and to have this development ready to represent at the commission meeting on Tuesday, September 17, 2019. It was agreed that this would be considered again at the September 17 meeting.
