MESSAGES FROM APPOINTED OFFICIALS

Item One: Mr. Jason VanBecelaere, Emergency Management Director and Undersheriff Steve Geier addressed the JAG Grant (Justice Assistance Grant) application. Mr. Geier stated that he spoke to Sheriff Peak and Sheriff Peak stated that he presented the JAG Grant in April or May of this year and the Commissioners approved the application but 3 days before the deadline the grant was shutdown. Mr. Geier said that the grant is now opened back up and the only difference in the applications is that the cost went up slightly. He explained that the price of the tower is totally on the county and Greenbush's share is \$8,500 for the road and to provide the land only. Mr. VanBecelaere and Mr. Geier discussed ways that the county's cost could be lowered. Mr. VanBecelaere also clarified that if the grant is approved, the county is obligated to put up the tower. Mr. Geier stated that radio contact on the west side of the county is horrible and this is needed. Commissioner Wood requested to table a decision until Tuesday. Mr. VanBecelaere will return on Tuesday to get the board's answer.

Mr. Wood stated that he gave Undersheriff Geier permission to look into prices for a drone. Mr. Geier explained different ways the drone could be helpful in the County. He is in the process of getting bids right now.

MESSAGES FROM THE PUBLIC
PROCLAMATION AND ORDERS OF THE BOARD
NEW BUSINESS

Item One: County Clerk Don Pyle stated that there is a group out of Springfield, Missouri called the Center for Voter Information that is sending out advance ballot applications with a postage paid envelope addressed to the Crawford County Clerk's Office to return the application. He explained that he wants the public to be aware that this is a valid form but the county did not send the application out. Mr. Pyle stated that

the group determines which voters are mailed forms. The Commissioner would like Mr. Pyle to check into the legality of this mailing with the Secretary of State's Office.

Item Two: Commissioner Wood requested that County Counselor Jim Emerson research the history of a road into Elk's County Club as far back as possible. Mr. Wood stated that he has done research on this road himself and is not sure if it is a county road. He stated that he will readdress this issue and discuss the findings on Tuesday.

Item Three: Commissioner Moody stated that he was contacted by Cato Historical Society asking for the County's assistance with some cleanup around the Cato School for Cato Days.

Item Four: Mr. Wood gave an update on the overlay on 220th St (Langdon Lane). Mr. Wood stated that Heckert Construction would be helping with this project and that the county will be billed for their services and that this should help the project to be completed sooner.

UNDER THE HEADING OLD BUSINESS

Item One: Mr. Emerson stated that several county counselors are discussing expanding nuisance powers. He said that he is working with the other county counselors on this issue. There was a discussion that this issue is not included in the KAC legislative platform and that there may be a push in the legislature to give counties some ways to recoup the cost of cleanup on nuisance properties.

Item Two: There was a discussion of the issues that Mr. Kenny Blair will be addressing in the commission meeting on October 2. The Commissioners then wanted to address the information received from Earle's Engineering regarding the potential Wastewater Regional Study and the determination of the fees to be paid by the entities involved. The Commissioners asked Mr. Pyle to get some additional information on how this study could be paid for.
