Item One: Deputy County Clerk Bobbi Wicker presenting the July 2015 Clerk's Report. Ms. Wicker stated that it summarizes the total amounts spent by departments for payroll and other bills during the month of June. Mr. Wood agreed and stated that each district is doing 9 miles of road for a total of 27 total miles.
