# UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

**Item One:** Ms. Janis Goedeke, Health Department Director addressed the Commissioners with an update on the status of the COVID-19 vaccination. She explained which organizations will be receiving the vaccinations and who the vaccines will be administered to first. She also stated that so far this week there have been 48 new cases of the virus.

# PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE PUBLIC

**Item One:** Mr. Brian Hanson addressed the Commissioners. He stated that he is the owner of McCarthy's Pub and has owned the business for 16 years. He expressed his concerns with a certified letter that he received from Crawford County on Friday about his business complying with the guidelines. He stated that he did not receive any phone calls or any other type of communication before this letter was received. Mr. Hanson asked what businesses in the County received the letter that he was sent, and County Counselor Jim Emerson answered that there were 9 business that the Pittsburg Police Department had visited in Pittsburg that were sent the certified letters. Commissioner Moody assured Mr. Hanson that it is not the intent of the Commissioners to shut any business down, but we are in the middle of a pandemic and guidelines must be followed in order to protect the public. He also stated that he is disappointed that no previous communication took place before the certified letter was sent. Mr. Hanson stated that he will be attending the meeting on Friday when Dr. Stebbins will be present to answer questions. Mr. Hanson stated that if he does follow the guidelines set out in the letter, he will have to close his business because the business will operate at a loss. Commissioner Johnson addressed the forums that were held with business owners and Pittsburg Area Chamber of Commerce President Mr. Blake Benson explained what has been taking place to make the businesses aware of decisions made in the Health Order. There was a discussion on having additional meetings or forums and other ways to communicate with local businesses on the Health Order guidelines.

# MESSAGES FROM ELECTED OFFICIALS MESSAGES FROM APPOINTED OFFICIALS

**Item One:** Mr. Michael Ehling, Executive Director of Community Mental Health Center of Crawford County regarding CMHCCC Operations. He presented the Commissioners with an Annual Report for Crawford County Mental Health for the year 2019. He reviewed the report with the Commissioners and explained the services they offer, who the services are offered to and where the services are offered. He spoke about community-based services. He also addressed the Case Manager positions and grants that

have been received. Mr. Ehling discussed the demographics of the individuals that are served as well as funding received and expenses.

#### MESSAGES FROM OTHER GOVERNMENTAL ENTITIES

Item One: Mr. Devin Gorman, Executive Director of the Convention and Visitors Bureau addressed the Commissioners and stated that the CVB Advisory Board met in December and approved the contract for 2021 between Crawford County, Kansas, the Crawford County Convention and Visitors Bureau and the Pittsburg Area Chamber of Commerce, the CVB budget and CVB Advisory Board appointments. He stated that Mr. Blake Benson, President of the Pittsburg Area Chamber of Commerce will present the contract. Mr. Benson addressed the Commissioners and explained the relationship between the CVB and the Pittsburg Area Chamber of Commerce and he stated that the contract spells out the ways the organizations work together. He explained the benefits to the county and the different services provided to the CVB that are set out in the contract. Mr. Benson stated that the contact is unchanged from last year. He discussed a major renovation to the facility that includes additional CVB space.

On motion (20-498) of Commissioner Johnson and the second of Commissioner Moody to approve the Contract for Services between Crawford County Kansas, Crawford County Convention and Visitors Bureau and the Pittsburg Area Chamber of Commerce for 2021 and authorize the Chairman to sign.

Mr. Gorman discussed board appointments for the CVB Advisory Board. He stated that the CVB Advisory Board has recommended 3 new board appointments, Ms. Sooki Fields, owner of Frisco Event Center & Fun Depot, Dr. Rick Hardy from PSU and Ms. Courtney Powell, Assistant Manager of Comfort Inn and Suites. He explained that the new board members will be replacing Mr. Joe Kennedy and Mr. Phil Minton who have termed out and Ms. Sherri Stephens who is moving out of the area. Mr. Gorman stated that these are 2-year appointments with the terms beginning in January of 2021.

for recommendation to the Commissioners the 2021 CVB Proposed Budget. He discussed the Museum Funds that are split with Crawford County and stated that in previous years the CVB has committed \$30,000 to that fund and this year the board recommended committing \$20,000 and explained the reduction was due to the reduced revenue from the Transient Guest Tax. The Commissioners expressed their concerns with the lower funding to the museums. The Commissioners would like Mr. Gorman to advise the museums of the funding cut and receive their input before they make any decisions.

Mr. Pyle stated that notices have been sent to the Sheriff, Zoning Administrator, County Attorney and the Township Clerk and that they were given 10 days to respond and that no responses had been received.
