NEW BUSINESS

Item One: County Counselor Jim Emerson regarding Resolution Number 20-004, a resolution renaming a road in the county. Mr. Emerson stated that Mr. Kyle Nelson, County GIS Director, had a received a request involving the name of a county road. Mr. Nelson stated that the City of Frontenac had requested that the name of the road that goes north from the intersection of 590th and 210th be changed. Mr. Nelson discussed that Frontenac had annexed property in the first half mile north of that intersection on the east side of the road for a residential development. Frontenac wants to rename the county road on the west side of this development so that the addresses will be in line with the other city addresses on that road from that intersection going south. Mr. Nelson suggested that the entire first mile of road going north from that intersection be named North Sugar Creek Road so that they will avoid changes in the street name and the sequence of street numbers in that mile section. It was discussed that keeping the current street name for part of that mile section could cause confusion for emergency personnel and law enforcement and would make it more likely to have mistakes in some online mapping systems.
