**Item One:** County Clerk Don Pyle informed the Commissioners that Mr. Terry Sercer, CPA with Diehl, Banwart, Bolton, CPAs will be attending a meeting in the near future to present the 2017 Crawford County Audit.

**Item Two:** Mr. Pyle discussed the Employee Assistance Program (EAP) through Blue Cross and Blue Shield and stated that some really good feedback has been received from the employees. He displayed monthly employee costs for the services and the different services offered. Mr. Pyle explained some of the services offered through EAP. He stated that IMA Consulting has looked at other companies that offer the same services and showed the different premiums for the different services for those companies. Mr. Wood requested copies of all the companies' premiums and services to do comparisons and Mr. Pyle will have that information ready Friday along with the employees' feedback on the EAP program.

**Item Three:** County Counselor Jim Emerson stated that Mr. Devin Gorman, Executive Director, Crawford County CVB contacted him in reference to the MOA Contract. He stated that Mr. Gorman has requested a 2-month extension on the renewal of the contract. He said that Mr. Gorman informed him that he is working on some issues and changes on the contract and Mr. Emerson explained some of the issues being discussed with PSU and the CVB. Mr. Emerson stated that Mr. Gorman will attend a work session with the Commissioners to go over the MOA contract changes before the final deadline date. The Commissioners requested that Mr. Gorman meet with them for a work session at 9:00 AM on July 10, 2018.

#### **ADDENDUM**

### PSU/CRAWFORD COUNTY, KANSAS MEMORANDUM OF SHARED USE AGREEMENT

This Addendum is made to the May 3, 2013 Memorandum of Shared Use Agreement (MOA) between Pittsburg State University (PSU) and Crawford County, Kansas (County) (collectively known as the Parties).

Whereas, said MOA expires on June 30, 2018 and the Parties want to extend and continue said MOA for an additional term commencing upon the expiration of the original term and it shall now expire on August 31, 2018. Provided, however, if the Parties enter into a newly negotiated MOA prior to August 31, 2018, this MOA shall expire as of the date of execution of the new MOA.

This Addendum extension agreement shall be binding upon and inure to the benefit of the parties, their successors and representatives.
