# UNDER THE HEADING NEW BUSINESS PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

**Item One:** Ms. Rebecca Adamson, County Health Officer addressed the Commissioners. She presented a map of the state that has different entities with different limited access guidelines. She stated cases are going up approximately 20% each day in the State of Kansas. She addressed the costs of the lab testing and billing insurance companies. There was a discussion on a fund that was set up for emergencies and Pandemic and using these funds for the pandemic COVID-19. She discussed positive tests and issuing isolation orders.

On motion (20-141) of Commissioner Moody and the second of Commissioner Blair to approve allowing the Health Department to access the COVID-19 fund.

She discussed the Governor's Executive Orders and presented a sample Order from the Crawford County Board of Health and County Health Officer. She explained that her recommendation is that this order be passed to decrease the spread of the virus. She discussed her duties as County Health Officer. She discussed the hardships business owners are experiencing during this time. Commissioner Johnson discussed the order. Ms. Adamson stated that this order can be passed today and then readdress if needed and make changes if necessary. She expressed her recommendation to approve this order. She stated that these recommendations are from the federal government and Kansas is not

acting alone and are following recommendations from the federal government. The Commissioners and Ms. Adamson discussed the actions of citizens and helping in not spreading in the virus. Ms. Adamson stated that this is an open-ended order and in effect until rescinded. She discussed the guidelines for different businesses set out in the order.

Mr. Blake Benson, Pittsburg Area Chamber of Commerce addressed the Commissioners and thanked the Commissioners and Ms. Adamson for their leadership during this time. He stated that he appreciates all the business owners that have concerns for the community's health and the health of their customers and employees and making sure their employees have jobs when this is over. Mr. Benson asked questions about manufacturers and other businesses and allowing employees to work. Mr. Benson discussed the responses from the restaurants that the chambers polled.

Ms. Jessica Ripper, Director of the Girard Chamber of Commerce addressed the Commissioners and stated that the businesses in Girard have been finding alternate ways they can still serve the public and stay open and others have closed specifically hair salons. She discussed aid to businesses that are becoming available.

Ms. Adamson stated that there are 89 counties in Kansas that do not have a confirmed case and the Governor is not issuing a stay at home order at this time.

Mr. Micky Pyle, Girard City Mayor addressed the Commissioners and explained what precautions the City is taking with their employees and reported on some of the businesses in the city. He also stated that the Council Meetings are being done by video.

Commissioner Johnson requested that essential government functions be added to the order. County Counselor Jim Emerson will amend the order and return.

It was discussed that the order should take effect 24 hours after the passing of the order.

MESSAGES FROM OTHER GOVERNMENTAL ENTITIES

**Item One:** Mr. Greg Gorman, Superintendent USD 246 addressed the Commissioners about face to face contact with the students. Ms. Adamson discussed the guidance sent to the districts from the Department of Education and stated that the decision is up to the County Board of Health and County Health Officer. She stated that she would prefer no face to face contact to limit the spread of the virus. Ms. Adamson stated that she has offered to meet one on one with each school district to go over their plans.

# MESSAGES FROM ELECTED OFFICIALS PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

Item One: Commissioner Johnson discussed limited hospital capacity and Ms. Adamson stated that is something that the hospitals are currently working on and Ms. Adamson stated she has not seen any plans as of yet. Mr. Johnson also asked about ventilator availability and Ms. Adamson explained that this issue is also being worked on and she does not have an exact count but each hospital does have a count. Mr. Johnson discussed day care at the Health Departments and Ms. Adamson stated that the Crawford County Health Department has not had to implement this.

**Item Two:** Commissioner Blair asked Ms. Adamson if she agreed with the procedures being taken at the Courthouse at this time and she stated that she sees no issues with this. Commissioner Blair asked about the procedure that would be implemented if an employee of a large business should test positive for the virus and Ms. Adamson explained the steps that would be taken.

#### **OLD BUSINESS:**

**Item One:** Commissioner Moody discussed the road and bridge crews and the precautions that are being taken and it was decided to make not changes with at this time.

**Item Two:** Commissioner Blair addressed Sheriff Smith about the Sheriff's Assistance Program and Sheriff Smith stated that they have assisted a few people. He discussed the calls they have been receiving.

#### MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH continued

**Item One continued:** Mr. Emerson presented the amended order with the changes requested. The Commissioners decided that the order will go into effect on Wednesday, March 25, 2020 at 12 Noon. Mr. Blair stated that any business that this puts a hardship on can come to the Commissioners with a plan. Ms. Adamson asked what the procedure is to be taken if the businesses have a plan. The Commissioners stated that the owners can call and ask to put on the agenda and speak with the Commissioners as the Crawford County Board of Health.

On motion (20-142) of Commissioner Johnson and the second of Commissioner Moody to approve the Crawford County Health Department Order of the Crawford County Board of Health and Public Health Officer to take effect March 25, 2020 at 12 noon and authorize the Chairman to sign.

**Item Three:** Mr. Emerson addressed no public access to the Courthouse and stated that they only time the public is allowed access is during the Commission Meetings and the public is screened before entering the building. He addressed the procedures to be taken in assisting the public with county business. He addressed county employees time off during this time and other precautions. He presented a draft of an Administrative Leave Policy and the issues addressed in the policy. He stated that part of the policy is the new federal guidelines as part of the Family Medical Leave Act and Childcare. The Commissioners will review and address at a later date.
