Item One: County Clerk Don Pyle regarding an email from Rick Beins of IMA Consultants requesting a conference call to discuss the TRIA Health proposal with the commissioners. Mr. Pyle stated that the representatives of IMA and TRIA are available for a conference call on Friday, June 1. There was a brief description of the information that was sent via email regarding their plans and the potential for savings. The commissioners decided to schedule a work session via conference call at 9:00 AM on Friday, June 1, 2018. There was a discussion of the copay amounts that members pay for their prescriptions and how that works for the mail order prescriptions.

Mr. Pyle gave the commissioners a summary of the responses that were received from employees on the survey that was completed by employees at the health insurance informational meetings. There was a discussion of the responses and that it would be good to get input from a larger percentage of the employees.

Item Three: Commissioner Wood regarding a resolution to approve the county Neighborhood Revitalization Policy.

Item Four: Commissioner Wood regarding the need for a mower to replace the one that is currently in need of repair. Mr. Wood stated that the new mower decks are just being shipped from Canada and he is not sure when they will arrive and be available for use. Mr. Wood stated that as soon as a new mower arrives, his crew will start using it to try to keep up with the mowing along county roads. There was also a discussion of the repairs that are needed and that our shop should be able to do the repairs.
