Mr. Gordon stated that the Crawford County Fire District #1 approved to present to the Commissioners the quote from Conrad Fire Equipment for a 2024 Pierce Freightliner Pumper with equipment in the amount of \$426,976.89. He explained that the pumper will not be delivered until May of 2024 and

He also spoke about purchasing rescue tools for the new truck. Mr. Gordon addressed the increase of cost in the pumper that is expected in the next few months. He stated that this purchase in is line with the departments 7-year replacement plan.
