NEW BUSINESS

Item One: County Clerk Don Pyle discussed the advance voting sites and Express Vote machines. Mr. Pyle answered Commissioner Moody's question about Crawford County students attending college out of state being able to vote in Crawford County.

Item Two: Commissioner Blair reported on the Ctec meeting he attended at the Kansas Crossing Casino and discussed the donations from Kansas Crossing Casino to Ctec reaching the \$1,000,000 mark. He also discussed the Constitutional Amendment Question that is on the ballot for this election and Mr. Pyle stated that the summary from the Secretary of State's office is on the Election's Facebook page and he will have it posted to the County website. Commissioner Johnson stated that he interviewed with KOAM-TV and also did a short explanation video on the question and has posted his video on his social media site. Commissioner Moody suggested that Commissioner Johnson's video be posted on the county website. Mr. Pyle stated that he has emailed the summary to the area media. Mr. Blair stated that everyone at the Ctec meeting was receptive to the recycling effort ideas.

Item Three: Commissioner Blair discussed Bridge #179 being replaced. Mr. Blair stated that bridge #179 has been approved by KDOT for replacement in 2021 with an 80/20

match and the funds need to be available in 2020. He stated that the county is responsible for 20% of participating funds and all the non-participating funds. Mr. Emerson explained that every two years CFS Engineers analyze each bridge and rates and prioritizes them. Mr. Blair stated that the estimated cost for the bridge to Crawford County is \$54,000. He explained that the bridge construction will be bid out by KDOT.
