NOTICE OF INTENT TO VACATE A PLATTED ALLEY

Pursuant to K.S.A. §58-2613, notice is hereby given that the Board of County Commissioners of Crawford County, Kansas proposes to close and vacate the following platted alley, to-wit:

An portion of unnamed alley located adjacent to and West of Lots Nine (9), Ten (10), Eleven (11) and Twelve (12) and East of Lots Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16) all in Block Nineteen (19) in the Town of Opolis, Crawford County Kansas, according to the recorded plat thereof;

A public hearing regarding said proposed road vacation will be held on Friday, April 24, 2020 at 10:00 a.m. in the Crawford County Courthouse, 2nd Floor, Commission Room, Girard, Kansas. All interested persons are encouraged to attend the public hearing.

If the Board of County Commissioners determines that the above-described platted alley is no longer required, or cannot be prudently be used for public purposes, the land comprising said alley shall revert to the adjoining landowners as originally taken for One Dollar (\$1.00), in the Commission Room at the Crawford County Courthouse, Girard, Kansas, on Friday, April 24, 2020 at 10:00 a.m.

RESOLUTION NO. 2020-006

A RESOLUTION CLOSING AND VACATING A PLATTED STREET AND ALLEY IN P.C. GUINN'S FIRST SUBDIVISION OF THE SOUTHEAST QUARTER, OF THE SOUTHWEST QUARTER OF SECTION 31, TOWNSHIP 30, RANGE 24, CRAWFORD COUNTY, KANSAS, ACCORDING TO THE RECORDED PLAT THEREOF.

WHEREAS, there is laid out and established in Crawford County, Kansas a certain street and a certain alley under the jurisdiction of the County, lying over and across the following described real estate:

An unnamed alley located adjacent to and North of Lots One (1) through Three (3) in Block One (1) in P.C. Guinn's First Subdivision of the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty-one (31), Township Thirty (30) Range Twenty-four (24) Crawford County Kansas, according to the recorded plat thereof; and

An unnamed street located adjacent to and East of Lot One (1), Block One (1) in P.C. Guinn's First Subdivision of the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty-one (31), Township Thirty (30) Range Twenty-four (24) Crawford County Kansas, according to the recorded plat thereof.

WHEREAS, a public hearing concerning said street and alley closing was held on the 27th day of March, 2020 and all interested parties were given an opportunity to present arguments for and against said closing;

WHEREAS, notice of the public hearing was published one time in the official County newspaper.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Crawford County, Kansas:

Section 1: The Board of County Commissioners finds that notice has been given as required by K.S.A. § 58-2613 and that the public will suffer no loss or inconvenience by such vacation and that no private rights will be injured or endangered thereby.

Section 2: Pursuant to K.S.A. § 58-2614, the above-described platted street and alley are hereby formally closed and vacated and the land comprising said street and alley shall and does hereby revert to the adjoining landowners in the same proportion as it was originally taken, subject and reserving unto the County and any public utilities, however, any right-of-way and easements for public service facilities and utilities which are in existence and in use across said roadway and right-of-way.

Section 3: The County Clerk is hereby directed to enter a record of these proceedings, as reflected in this Resolution, on the Journal of the Board of County Commissioners and to record a certified copy of this Resolution in the Register of Deeds office.

Section 4: The County Clerk is directed to send a copy of this Resolution to each owner of the adjoining real estate to whom the property is being transferred, at the address where the owner's tax statement is sent.
