NOTICE OF INTENT TO VACATE A PLATTED STREET

Pursuant to K.S.A. §58-2613, notice is hereby given that the Board of County Commissioners of Crawford County, Kansas proposes to close and vacate the following platted street, to-wit:

A portion of Sixth Street located adjacent to and East of Lots Six (6) through Twelve (12) in Katie Addition to the Town of Dunkirk (part of the Northeast Quarter (NE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-six (36), Township Twenty-nine (29) Range Twenty-four (24) Crawford County Kansas, according to the recorded plat thereof; and

A public hearing regarding said proposed road vacation will be held on Friday, August 7, 2020 at 10:00 a.m. in the Crawford County Courthouse, 2nd Floor, Commission Room, Girard, Kansas. All interested persons are encouraged to attend the public hearing.

If the Board of County Commissioners determines that the above-described platted street is no longer required, or cannot be prudently be used for public purposes, the land comprising said street shall revert to the adjoining landowners as originally taken for One Dollar (\$1.00), in the Commission Room at the Crawford County Courthouse, Girard, Kansas, on Friday, August 7, 2020 at 10:00 a.m.

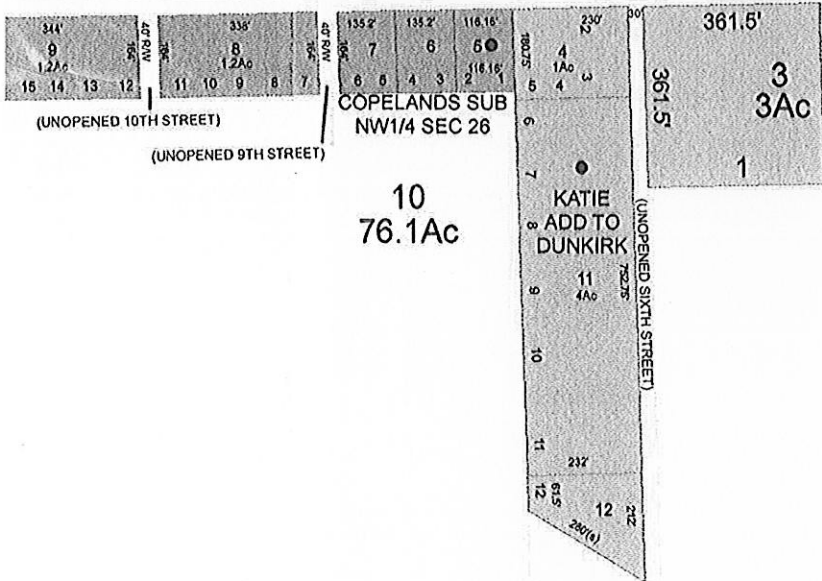
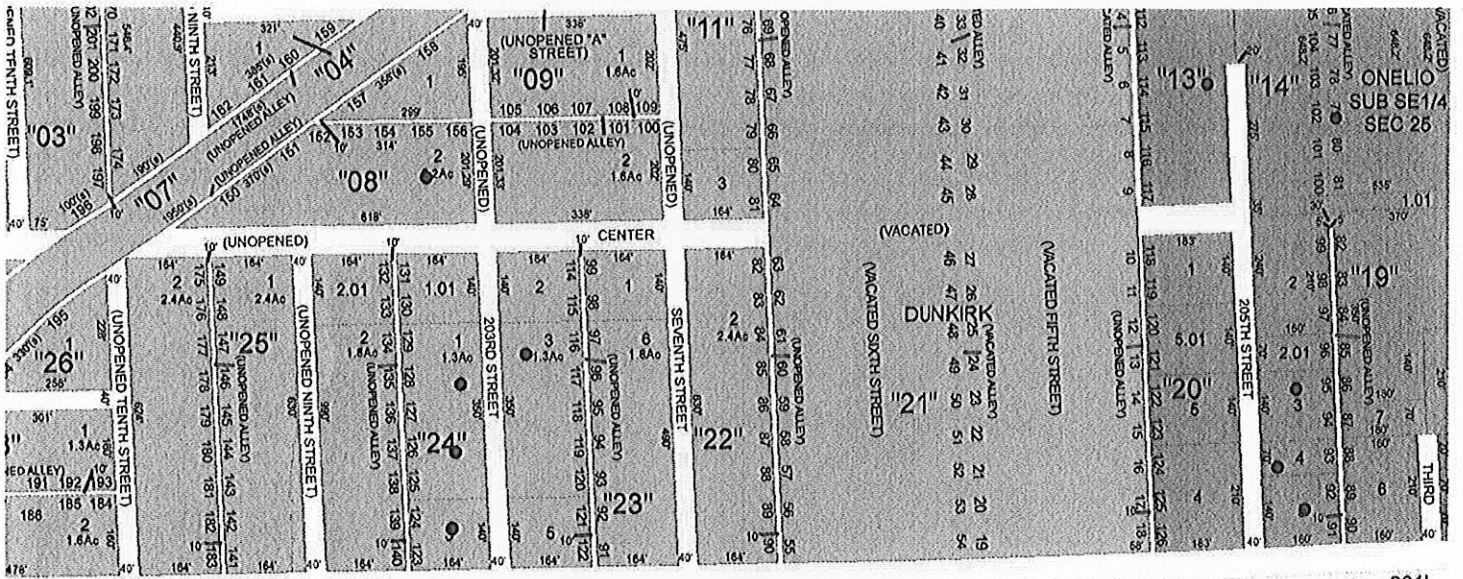

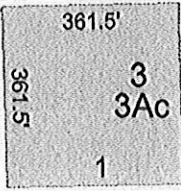
