## Application for 2023 Dust Control

**The Crawford County Dust Control Program consists of the application of DustGard®, a Magnesium Chloride Solution (MgCl<sub>2</sub>) to gravel roads in the County. Dust Control Programs are not required in the State of Kansas and Crawford County offers this service to the County residents in an effort to help abate the dust created by traffic. The application of dust control treatment will not eliminate dust. The effectiveness and duration of the dust control treatment is dependent on traffic volumes, weather, thickness of gravel, drainage, etc.**

**This is the only dust control program offered or recognized by the County. The County does not warrant the product in any way and the applicant agrees to help Crawford County harmless for the failure of this product: this product will be provided by an independent contractor.**

**The Deadline to apply for this program is May 20, 2023. Payment will be held until exact date of application is determined.**

A single treatment application will be used. The exact date of the treatment will depend on weather conditions and product availability. Our current time frame for application is Late May. Flags will be placed by the county the week before application to mark locations of areas to be treated.

The County will make every effort to not disturb the treated area during a period ending in September 2023, **but reserve the right to maintain the road at any time it is determined necessary to provide a safe public roadway. Neither refund nor retreatment will be made for shortened dust control treatment life resulting from required maintenance.**

After that time, the County will resume normal maintenance operation. Maintenance activities on dust control areas, as with other parts of the county road system, will be solely at the discretion of the Road & Bridge Foreman.
