**Item One:** County Clerk Lisa Lusker stated that she has scheduled the work session that the Commissioners requested with Dr. Jacqueline Youtsos, Ms. Ann Elliott and Mr. Ron Scripsick to address ARPA funding for large child care facilities on May 9, 2023 at 9:00 AM.

**Item Two:** County Counselor Jim Emerson stated that Commissioner Blair is attending a funeral this morning and was not able to attend the Commission Meeting. He said that Commissioner Blair attended the KCCA meetings in Hays this week and requested that he inform Commissioner Moody and Commissioner Wood about the ABODE program through the Department of Commerce that was discussed in the meeting. Mr. Emerson explained that this program is through State ARPA funding and is a program for building opportunities for remodel and new construction for the elderly and disabled. He said that he gave the information to County Grant Writer Gus Brunetti to review.

Item Three: Mr. Emerson presented information on Grants for RJA. He explained that he is presenting these grants for Ms. Angie Hadley, Director of the Restorative Justice Authority. He stated that these are the main grant programs for RJA for the year and are due May 1, 2023. He explained each of the grants and the fund allocations: the FY24 Comprehensive Plan Grant, Reinvestment Grant FY24-25, the Regional Collaboration Grant FY24-25, the Juvenile Corrections Advisory Board (JCAB/Evidence Based Program Grant FY24-25, the Juvenile Crime Community Prevention Grant for Crossover Youth (Truancy Intervention Program) FY24 and the Juvenile Crime Community Prevention for Crossover Youth (Prevention Engagement Program) FY24. Mr. Emerson explained that these grants require the Chairman's signature and Commissioner Blair will sign after approval. Mr. Emerson presented the Commissioners with a listing of the Juvenile Corrections Advisory Board members.

On motion (23-190) of Commissioner Moody and the second of Commissioner Wood to approve the Restorative Justice Authority Grants as presented and authorize the Chairman to sign.
