PROCLAMATION AND ORDERS OF THE BOARD MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: County Health Officials with COVID-19 update. Deputy County Health Officer Ms. Teddi Van Kam presented the Commissioners with the Crawford County Gating Criteria updated 4/29/2021. She reviewed the Community Gating Criteria and the School K-12 Gating Criteria. She stated that Ascension Via Christi currently has 3 positive COVID-19 individuals, no persons under investigation, no COVID-19 cases on ventilators and they have plenty of bed availability and the staffing situation is good. Ms. Van Kam discussed a new anti-body treatment and explained that both hospitals have received the treatment and Ascension Via Christi and Girard Medical Center each have given three doses with no issues. She gave information on vaccination clinics. Commissioner Moody stated he received a letter from a citizen praising the Health Department and Commissioner Moody thanked Ms. Van Kam and the Health Department staff for all they do.
