UNDER THE HEADING NEW BUSINESS PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: County Health Officer Rebecca Adamson stated that the county is still under the governor's orders. She said that she issued a press release yesterday that Crawford County has its 6^{th} case of the virus. She explained that out of the 6 cases, there was 1 death, 1 individual still in isolation, which is the latest case and 4 individuals have recovered and are out of isolation. She also stated that there are a lot of test results still

pending. Commissioner Moody asked when to expect the blunt of the cases and Ms. Adamson answered that through guidance from KDHE the peak should be around April 24. Sheriff Smith stated that the businesses are all doing a very good job of following procedures. He discussed getting the urgency out to the public of the seriousness of the situation. Ms. Adamson stated that there is an LEPC meeting on April 9 via phone and the homeless challenges will be discussed. Sheriff Smith stated that the Sheriff's assistance program has assisted quite a few individuals. He discussed the essential and non-essential businesses and the where the decision should lay in deciding essential versus non-essential. Sheriff Smith discussed some of the questions his department has had. He discussed concerns with the stay at home order and domestic violence and mental health issues but said at this time has not seen an upswing of these problems. He stated that his departments have sufficient supplies at this time and has had no issues with this. Ms. Adamson discussed the areas hospitals' working on surge capacity. Mr. Michael Ehling, Mental Health Executive Administrator addressed the Commission and discussed the procedures his offices are taking and discussed Telehealth. He spoke about the Addiction Treatment Center and stated that admissions have been stopped at this time. Mr. Ehling stated that his department is going to do some radio and tv spots to make the public aware that they accessible 24 hours a day, 365 days a year. EMS Director Randy Sandberg reported on his department and stated that the call volume has actually went down during this time. He stated that Mr. Rusty Akins, Emergency Management Director did an excellent job in obtaining the supplies that his department needed. He also discussed the surge plan and stated that he will be meeting with EMS Administrator Dr. Stebbins this afternoon about the surge plan. Commissioner Moody asked Mr. Sandberg to return next week to give an update on his meeting with Dr. Stebbins.

He explained that the county has paid the company \$28,800 which leaves a balance on the original contract of \$7,200.00 which he recommends that the county pay. Mr. Blair stated that he would like a set of new drawings as constructed for the changes that took place and some additional documents signed by Mr. Wicker of Heck & Wicker. Mr. Johnson discussed the contract prices. Mr. Emerson will return with additional information.

Item Two: Mr. Johnson addressed Mr. Ehling and asked about the new addiction treatment center and Mr. Ehling stated that it has been paused at this time due to the circumstances.
