The Crawford County Board of Commissioners met pursuant to Kansas Statutes

Annotated Chapter 19, Article 2, Section 18 in due and regular session with open doors.

Commissioner Carl Wood served as the presiding officer.

Commissioners Tom Moody and Jeff Murphy were in attendance.

County Clerk Don Pyle and County Counselor Jim Emerson were seated with the Board.

Chairman Wood led the pledge of allegiance.

Item One: Mr. Pyle stated he spoke to Ms. Christy Downing from IMA and they will be here on August 29, 2017 with information on different coverages.

Item Two: Commissioner Moody discussed rock reports. He stated that it might be helpful to have the foreman write the area on the rock tickets. The Commissioners discussed the current work being done on the roads and the work that is still left to do. The Commissioners commended the road crews on how well they are working together. They also discussed the new seat for the roller.

Item Three: Commissioner Wood stated that he received a bid on a 313 Track hoe of \$159,962.00 with a 5 year extended warranty. The Commissioner discussed having operators of the track hoe from each district. The Commissioners decided to have the track hoe operators all look at the machine before making any decisions.

Item Four: Mr. Wood addressed the sick pool policy. Mr. Emerson explained how the sick pool works. He stated that there is only 1 person at this time on the sick pool committee and 2 more volunteers are needed to complete the committee. The Commissioner discussed options for other committee members. Mr. Pyle will get information on usage of the sick pool in the past, days that are currently in the pool and the number of participants in the pool. Mr. Emerson will work on getting new members on the committee.

UNDER THE HEADING OLD BUSINESS

Item One: Mr. Emerson stated that the 2 road and bridge building contracts have been signed.

Item Two: Commissioner Murphy stated that he has set up a meeting with the City of Pittsburg on the EMS Service at 9:00 AM on August 29, 2017. He stated that Mr. Jay Byers and Mr. Daron Hall from the City, Dr. Stebbins and Mr. Randy Sandberg will be present. The Commissioner decided to have the meeting in a work session.

Item Three: Mr. Murphy addressed the bridge by Walnut that he would like to have torn out and replaced. He stated that he looked at using railroad tank cars and would need three ½ tank cars at \$7,500 a piece which would total \$22,500 and feels that is too costly. He informed the Commissioners that he priced plastic culverts and stated he would need five 5 feet culverts at \$.81 per foot which would be \$12,960 total. Mr. Murphy said that he would like approval to purchase the culverts with flowable fill and rock for a total cost of under \$15,000. Mr. Moody stated he would like traffic count on that road and Mr. Wood stated that and only counter the county has is for a hard surface and would not work on this road. Mr. Murphy said that he would like to have it done in the next 2 or 3 months after the chip and seal projects are completed. The Commissioners approved Mr. Murphy purchasing the supplies for replacing this bridge.

Item Four: Commissioner Wood discussed different machinery for the road and bridge department.

Item Five: Commissioner Murphy stated that there is a KDOT Conference on September 6, 2017 in Topeka and he has some of his crew members attending.
