#### MESSAGES FROM THE COUNTY LOCAL BOARD OF HEALTH MESSAGES FROM APPOINTED OFFICIALS

**Item One:** Ms. Debra Anthony, Crawford County Health Department and Chairman of the Crawford County Wellness Committee addressed the Commissioners in reference to the Blue Cross and Blue Shield Pathways to a Healthy Worksite Grant. She stated that she is requesting that the Commissioners' approve the Pathways to a Healthy Worksite Pledge and authorize the Chairman to sign. She explained that this is the grant that Mr. Brad Stroud, Live Well Crawford County Director oversees. Ms. Anthony spoke about the Wellness Committee and the criteria the members have met for this grant.





#### Pathways to a Healthy Worksite Pledge

<u>Crawford County, Kansas</u>, hereby affirms our commitment to taking on new opportunities that provide greater access to a healthy lifestyle for our employees. We are aware our involvement helps to establish strong community norms for healthier living and we are willing to learn more about making healthy environment and policy changes to help our employees, their families, and community members live longer and better quality lives. We will accept information and assistance from the Live Well Crawford County through *Pathways to a Healthy Kansas*, a Blue Cross and Blue Shield of Kansas initiative, to implement comprehensive worksite wellness strategies at our worksite.

Live Well Crawford County shall:

- host WorkWell Kansas (WWKS) workshops that will educate our wellness committee about the foundation and framework for comprehensive worksite wellness and provide assistance and tools for getting started;
- provide publicity in the form of press releases and recognition on the BCBSKS Pathways (bcbsks.com/Pathways) and Live Well Crawford County's websites highlighting our participation as an employer committed to the health of our community and updates on progress we make related to this initiative;
- develop materials to promote our involvement in the *Pathways to a Healthy Kansas* initiative;
- create opportunities for shared expertise and interaction with peers.

Employers are an integral piece of the community, and we acknowledge our influential position to assist our employees and all members of our community in living healthier lives. We are committed to taking steps toward providing the healthiest possible work environment at our worksite.

County Counselor Jim Emerson addressed Ms. Anthony on the issues on the BC/BS website being hard to maneuver and input the information and Ms. Anthony stated that the Wellness Committee is looking into it. She stated that this is the first year that all employees had their information entered into the website by the deadline of December 1, 2017.

**Item Two:** Mr. Brad Stroud, Live Well Crawford County Director gave a report on the Food Policy Grant (FPC Implementation Grant) through the Kansas Health Foundation. He stated that this grant was used to construct the High Tunnel. He explained that this was a \$40,000 grant and was divided in half with \$20,000 for worksite wellness and \$20,000 for food production. Mr. Stroud showed the Commissioners the breakdown of the expenditures of the grant and explained the details. Mr. Wood expressed concerns on the way the grant monies were spent. There was a discussion on the grant and the high tunnel and what has taken place and what is planned for the future. The Commissioners thanked Mr. Stroud for bringing and explaining the report.

#### MESSAGES FROM OTHER GOVERNMENTAL ENTITIES

**Item One:** Mr. Mike Ryan, Fire Chief and Mr. Rick Wilson, President of the Board, Crawford County Fire District #1 addressed the Commissioners about a 2017 budget amendment for the district. Mr. Ryan stated that he would like to amend the 2017 budget to use the cash that is left and put it into the equipment fund. Mr. Pyle stated that he worked up a preliminary budget amendment and explained the amendment. Mr. Pyle stated that the district would probably need a small cash carry over for the next year's budget. Mr. Ryan stated he will contact Mr. Pyle after the next board meeting and inform him what the expenditures will be for that month so Mr. Pyle can determine what is needed in the budget amendment. Mr. Pyle stated that he will work on the budget amendment and also budget amendments for Crawford County Fire District #2 and Crawford County Fire District #3.

Mr. Ryan addressed fire trucks and stated that bids have been received. He explained that the district used Houston Galveston Purchasing Agreement and explained how the bidding company works up the bids. He stated that Weis Fire Company out of Salina was the bid chosen at \$360,000 to replace 2 grass trucks and move rescue equipment to a 1-ton truck. Mr. Ryan explained that this would be acquired on a lease purchase. He also stated that the trucks will not be ready for 9 to 12 months and he is needing permission from the Commissioners to enter into the contract to get the process going. The Commissioners approved.

**Item Three:** Mr. Pyle presented applications for 2018 Cereal Malt Beverage Licenses for Anthony Pichler "Pichler Chicken Annie's" to allow them to sell cereal malt beverages for consumption on the premises and to allow them to sell cereal malt beverages in original and unopened containers and not for consumption on the premises. Mr. Pyle explained that both licenses are for the same premises. Mr. Pyle stated that notices have been sent to the Sheriff, Zoning Administrator, County Attorney and the Township Clerk and that they were given 10 days to respond and that no responses had been received.

**On motion (17-397)** of Commissioner Moody and the second of Commissioner Murphy to make it known that the matter of issuing a license to the applicant(s) listed below was discussed and considered by the Board, and there being no objection filed as provided by law and the Board knowing of no reason why a license should not be issued, the board hereby issues a license to "sell at retail", cereal malt beverages in broken case lots from the place of business as shown in the application as designated and described on the application as herein before set out, and that the County Clerk be hereby authorized and directed to execute the proper license which shall be signed by the Chairman of the Board of County Commissioners and the County Clerk of Crawford County, Kansas.
