The Crawford County Board of Commissioners met pursuant to Kansas Statutes.

Annotated Chapter 19, Article 2, Section 18 in due and regular session with open doors.

Commissioner Jeremy Johnson served as the presiding officer.

Commissioners Tom Moody and Bruce Blair were in attendance.

County Clerk Don Pyle and County Counselor Jim Emerson were seated with the Board.

Item One: Mr. Mike Bodensteiner, Greenbush, and Mr. Steve Brooks, City of Girard Public Utilities Director, addressed the Commissioners in reference to the American Rescue Plan Act funding. Mr. Bodensteiner recommended the Commissioners consider funding the City of Girard's lift station immediately, as KDOT matching funds must be applied for immediately and the repairs are badly needed. Mayor Dave Fornelli from the City of Frontenac also spoke about the need for ARPA funding to help pay for the City of Frontenac's infrastructure project. The Commissioners decided the City of Girard and the City of Frontenac will both receive funding based upon an equal per resident amount.

On motion (21-409) of Commissioner Blair and the second of Commissioner Moody to approve the City of Girard and the City of Frontenac's requests for ARPA funding based on a per resident formula in which the City of Girard is awarded \$506,626 and the City of Frontenac is awarded \$683,164. Item Two: Mike Bodensteiner also discussed the childcare portion of the ARPA fund requests. The Board approved a draft letter created by Mr. Bodensteiner that requests more information from applicants for Childcare Funding.

He stated that the funds that need amending are the General, Road & Bridge, Ambulance, Employee Benefits, Consolidated 911 and Clerk Technology funds. He explained the reasons the budget amendments are needed. He would like to schedule the public hearing on the amendments for December 28, 2021 at 10:00 AM. Mr. Pyle stated that the notice must be published at least 10 days prior to the hearing date.

On motion (21-411) of Commissioner Blair and the second of Commissioner Moody to approve the publication for the 2021 Budget Amendment for Crawford County and to set a hearing date of December 28, 2021 at 10:00 AM. Yeas: Commissioners Moody, Blair and Johnson Nays: Present but not voting: Absent or not voting: **The motion prevailed.**

Item Two: Mr. Pyle addressed the 2021 Budget Amendment for Crawford County Fire District #1, Fire District #2, Fire District #3 and Fire District #4. Mr. Pyle explained the reason for the amendment.

On motion (21-412) of Commissioner Blair and the second of Commissioner Moody to approve the publication for the 2021 Budget Amendment for Crawford County Fire District #1, Fire District #2, Fire District #3 and Fire District #4 and to set a hearing date of December 28, 2021 at 10:00 AM. cereal malt beverages for consumption on the premises and "Jo's One Stop" to allow them to sell cereal malt beverages in original and unopened containers and not for consumption on the premises. Mr. Pyle stated that notices have been sent to the Sheriff, Zoning Administrator, County Attorney and the Township Clerk and that they were given 10 days to respond and that no responses had been received.

On motion (21-413) of Commissioner Moody and the second of Commissioner Blair to make it known that the matter of issuing a license to the applicant(s) listed below was discussed and considered by the Board, and there being no objection filed as provided by law and the Board knowing of no reason why a license should not be issued, the board hereby issues a license to "sell at retail", cereal malt beverages in broken case lots from the place of business as shown in the application as designated and described on the application as herein before set out, and that the County Clerk be hereby authorized and directed to execute the proper license which shall be signed by the Chairman of the Board of County Commissioners and the County Clerk of Crawford County, Kansas.

Item One: Sheriff Danny Smith presented the Commissioners with a proposal to switch the sworn full-time members of the Sheriff's Office from the Kansas Public Employees Retirement System (KPERS) to the Kansas Police & Fireman's Retirement System (KP&F) He stated that KP &F is geared towards first responders and public safety employees. He explained the benefits in switching to KP&F.

On motion (21-416) of Commissioner Moody and the second of Commissioner Johnson to approve changing the retirement plan for the sworn full-time members of the Sheriff's Office from the Kansas Public Employees Retirement System (KPERS) to the Kansas Police & Fireman's Retirement System (KP&F). Yeas: Commissioners Moody, Blair and Johnson Nays: Present but not voting: Absent or not voting: **The motion prevailed.**

Item Five: Commissioner Blair discussed trucks for the Road & Bridge Department. He discussed the Freightliner trucks that have been ordered and stated that those trucks will not be in until the middle of next year. He presented a quote for 2 2022 International Dump trucks from Summit Truck Group that are available now.

On motion (21-417) of Commissioner Moody and the second of Commissioner Blair to approve the purchase of 2 2022 International HV507 Dump Trucks with a 5 year/300k warranty for the total price of \$318,400 and authorize the Chairman to sign. Item Six: Commissioner Moody stated that he would like Shop Foreman Josh Peak to look into 1-ton trucks. Mr. Blair will contact Mr. Peak on this issue.
