PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE COUNTY LOCAL BOARD OF HEALTH MESSAGES FROM THE PUBLIC

Item One: Mr. Chris Bohrer, Wood & Dulohery Insurance, regarding Cyber Solutions insurance coverage. Mr. Bohrer stated that the prices for cyber coverage were in his bid package when he turned in his bid for property, casualty and work comp insurance and his recommendation was to carry additional cyber coverage. Mr. Vinze stated that he has looked over the bid and discussed the bid with Mr. Bohrer. Mr. Wood feels that Mr. Vinze should set up specs on what cyber coverage the county needs so others can bid on this. Mr. Moody would like to know Mr. Vinze's recommendation on what the county needs. It was decided not to discuss the bid price but Mr. Bohrer can discuss coverages. Mr. Bohrer discussed cyber coverages and gave examples of other entities that needed and used the cyber coverage. Mr. Vinze also discussed how issues could happen at Crawford County where the cyber coverage could be needed. Mr. Bohrer explained the coverages. Mr. Pyle stated that the county has been carrying cyber coverage the last few years. It was decided that Mr. Vinze will set up bid specs for the cyber coverage so the county needs are met.

MESSAGES FROM ELECTED OFFICIALS MESSAGES FROM APPOINTED OFFICIALS

Item One: Mr. Troy Graham, Zoning Administrator discussed changes to the nuisance policy and information on codes court. Mr. Graham stated that more than 3 inoperable vehicles will be considered a nuisance. He explained the regulations used to determine if a vehicle is inoperable and should be considered a nuisance. Mr. Graham stated that a resolution is needed to create the codes court and that a judge will need to be appointed for codes court. Mr. Graham will present a resolution next Friday to set up codes court. Mr. Moody discussed property on 69 Highway around Franklin that needs to be cleaned up and Mr. Graham stated that he will mail the landowner a certified letter today. Mr. Murphy discussed some typographical errors in the nuisance policy that need corrected.

Item Two: County Counselor Jim Emerson presented the contract with Capitol Strategies and Crawford County for services for Mr. Bill Brady, the County lobbyist. Mr. Emerson stated that he has contacted Mr. Brady and he will setup a meeting during County Government Day on January 24, 2018 with the Insurance Commission.

CONTRACT

This Contract is entered into between Capitol Strategies, LLC, and Crawford County, and is as follows:

Capitol Strategies agrees to provide monitoring and reporting representation to Crawford County through the 2018 Legislative Session, specifically to:

- 1) Monitor and report on legislative committee meetings involving issues of interest to Crawford County.
- 2) Monitor and report on other public meetings involving state government issues of interest to Crawford County. Meetings outside of Shawnee County will be approved on a case by case basis.
- Work as directed by Crawford County to assist other entities and institutions within Crawford County with monitoring and reporting activities.
- 4) Provide advice and counsel as directed on state government issues of interest to Crawford County.
- 5) Assist as directed in representing the County at any Crawford County events during the legislative session such as "County Official Day" and "Crawford County/City of Pittsburg Day at the Capitol".
- Assist and/or coordinate meetings requested by Commissioner and key county staff with various state personnel.
- 7) File all reports with the Kansas Ethics Commission regarding our lobbying activities.

Capitol Strategies agrees that at all times they will be independent contractors and will be responsible for payment of all taxes on monies received.

Crawford County agrees to pay Capitol Strategies \$10,000 for the 2018 session, to be made in two payments. The first payment is due 10 days following the date this contract is signed. The final payment is due by March 15, 2018. In addition, expenses will be billed for out-of-pocket charges such as lobbyist registration fees, travel outside of Shawnee County, conference calls, postage and copying for mass mailings. Those expenses will not exceed \$500.00 during the period of this contract without the express permission of Crawford County.
