PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS
MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: Dr. Tim Stebbins, County Health Officer addressed the Commissioners via Zoom. County Health Director Janis Goedeke handed out copies of the Crawford County Gating Criteria updated 12/28/2020. Dr. Stebbins stated that currently Ascension Via Christi has 16 positive admissions and Girard Medical Center had 3 positive cases as of yesterday. He updated the Commissioners on the hospitals' capacities and the Monoclonal Antibody doses given and the doses still available. He also updated the Commissioners on testing and the outcomes. Dr. Stebbins went through the Community Gating criteria for the community and for the schools K-12.

Deputy County Health Officer Dr. Linda Bean addressed the Commissioners and discussed the overall incidence rate and the positivity rate. Dr. Stebbins wanted to clarify that the Gating Criteria presented today reflects the information from last week, as of last Saturday.

Ms. Goedeke addressed the Commissioners. She stated there is funding for testing through Well Health through the end of January. She said that she has a fear that after Christmas there might be a spike in cases. She explained that the Health Department had already received faxes with 30 new cases this morning when the department opened its doors and those cases are not in the numbers that Dr. Stebbins reported on. She gave a

report on the vaccination doses that were received and explained issues with scheduling. Mr. Moody was answered that there has not been a firm date set yet for the next shipment of doses. Dr. Bean reported on who has been receiving the vaccinations and who is eligible for the vaccines in the first wave and the next wave of doses to be received. She also explained the 2-dose vaccination and when the 2nd dose will be administered. Ms. Goedeke and Dr. Bean explained the CDC guidelines for quarantine times.
