**Item One:** Mr. Mike Bodensteiner addressed the Commissioners. He stated that they are wrapping up the small child care ARPA funding and he presented a total of 7 small child care facilities that he recommends funding. He explained that there is one facility that the license is pending and he suggests approving the funding with a memorandum of agreement but not distribute the funds until the license is received.

On motion (23-071) of Commissioner Wood and the second of Commissioner Blair to approve ARPA funding for seven small child care facilities as presented by Mr. Mike Bodensteiner. Yeas: Commissioners Blair and Wood Nays: Present but not voting: Absent or not voting: Commissioner Moody The motion prevailed.

**Item Two:** Mr. Matthew Godinez, Executive Director of SEKRPC addressed the Commissioners. Mr. Godinez shared good news with the commissioners, the SEKRPC was awarded an \$800,000 grant called Safe Streets for All. This money will pay for architects and engineers to assess all roads in the region. This funding is provided by the new infrastructure bill. Mr. Godinez also provided a snapshot of grant money brought into Crawford County over the years. Mr. Godinez explained that if the county pays the large membership dues to SEKRPC, access to services provided is given to all cities included in the county. Mr. Godinez stated meetings are the first Thursday of the month, and asked for a nomination of a board member to represent the county.

**On motion (23-072)** of Commissioner Blair and the second of Commissioner Wood to approve payment of the 2023 dues to the Southeast Kansas Regional Planning Commission in the amount of \$8,245.80. **Item Three:** Mr. Emerson discussed Riley County and Senate Bill #162 on nuisance violations. He stated that this bill will be heard by the Senate local government committee on Tuesday, February 14, 2023. He explained that the bill is specific to Riley County and said that Crawford County would like to be added to this bill or added and amended later. He stated that he has been working on some testimony to support this legislation and the County Lobbyist Mr. Bill Brady, himself and Commissioner Wood will be attending the hearing. Commissioner Blair stated that he would also like to be there. Mr. Emerson stated that in order for them to attend, the Regular Session scheduled for February 14, 2023 will need to be cancelled due to lack of quorum to attend the hearing. Mr. Emerson explained the County's authority in addressing nuisances in prior years and the current authority the County has. He explained that the ultimate nuisance enforcement would be the ability to clean up the property and assess the costs to the tax roll and this is what Riley County is asking for in Senate Bill #162.
