MESSAGES FROM THE PUBLIC PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

Item One: Mr. Pyle informed the Commissioners that he attended the Fence Viewing Meeting at the Girard High School Cafeteria last night. He stated that the speaker, Roger McEowen, Kansas Farm Bureau Professor of Agricultural Law Taxation, was very informative and answered many questions from the audience. Mr. Pyle said that Troy Graham, County Zoning Administrator and Ed Fields, County Noxious Weed Director were both in attendance at the meeting. A discussion was held on fence viewing in the County. Mr. Pyle informed the Commissioners about other topics that were discussed during the meeting.

Item Two: Mr. Pyle addressed the Risk Management Fund. Mr. Pyle discussed funds that had more cash carryover that projected in the 2017 budget. There was a discussion on transferring the excess cash carryover from the funds into the Risk Management Fund. The Commissioners decided to transfer \$75,000 from these funds into the Risk Management Fund.



On motion (17-064) of Commissioner Moody and the second of Commissioner Wood to approve a transfer of \$75,000 from the Road & Bridge Fund, Ambulance Service Fund County Health Fund and Employee's Benefit Fund to the Risk Management Fund. Item Four: Mr. Jim Emerson, County Counselor presenting Resolution #2017-004, a Resolution Changing the Speed Limit on 515th Avenue Between 240th Street and 250th Street, Crawford County, Kansas. Mr. Emerson stated that Mr. Wood had requested Sheriff Peak do a speed study on this road which is currently unmarked. Mr. Emerson stated that the resolution will set the speed limit at 35 miles per hour.



RESOLUTION NO. 2017-004

A RESOLUTION CHANGING THE SPEED LIMIT ON 515th AVENUE BETWEEN 240TH STREET AND 250TH STREET, CRAWFORD COUNTY, KANSAS.

WHEREAS, the Board of County Commissioners is authorized under K.S.A. $\$8-1560\,(h)$ to determine the proper maximum speed for county roads and shall declare a reasonable and safe maximum limit thereon; and

WHEREAS, the Board of County Commissioners, upon reviewing the recommendation of the Sheriff's Department, finds it is necessary to lower the maximum speed limit on 515th Avenue between 240th Street and 250th Street.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Crawford County, Kansas:

Section 1: That the maximum speed limit on 515th Avenue between 240th Street and 250th Street is hereby set at 30 miles per hour.

Section 2: The Crawford County Road and Bridge Department is hereby authorized to post speed limit signs according to the maximum speed established in Section 1 of this Resolution.

Section 3: It shall be unlawful for any person to operate a motor vehicle on such road in excess of such maximum speed limit.

RESOLUTION NO. 2017-005

A RESOLUTION PROHIBITING THE OPERATION OF TRUCKS AND COMMERCIAL VEHICLES ON PORTIONS OF 240TH STREET, CRAWFORD COUNTY, KANSAS.

WHEREAS, the Board of County Commissioners is authorized under K.S.A. §§ 8-1912, -2002, 19-101a to impose limitations as to the weight or size of trucks or commercial vehicles on roads under its jurisdiction; and

WHEREAS, County authorities have determined that trucks and commercial vehicles traveling on the roads hereinafter described constitute a hazard to public health and safety and cause excessive deterioration of the roadway.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Crawford County, Kansas:

Section 1. The terms "truck" and "commercial vehicle" when used herein shall have the following meaning:

Truck or commercial vehicle shall include any vehicle known as a truck, semi-trailer, truck tractor or trailer, whether self-propelled, towed behind or pushed ahead of a vehicle, whenever such vehicle, alone on or in combination with other vehicles, has a gross weight of 12,000 pounds or more.

<u>Section 2</u>. That all trucks and commercial vehicles be and are hereby prohibited from traveling on that portion of 240th Street located between $520^{\rm th}$ Avenue on the south end and $540^{\rm th}$ Avenue on the north end under the Crawford County, E-911 System.

from this $\frac{\text{Section 3}}{\text{ordinance:}}$ The following vehicles are hereby exempt

(1) Local farm tractors, combines, fertilizer dispensing equipment or other farm machinery traveling to and from a site or sites located along or adjacent to said roadway.

(2) Vehicles owned by counties, cities, and other political subdivisions of the State.

(3) Any truck or commercial vehicle owned by or leased to or contracted with a franchised utility while engaged in repair, maintenance or construction activity on or adjacent to said roadway.

(4) Any truck or commercial vehicle making a pickup at or a delivery to a site located along or adjacent to said roadway.

(5) Any truck or commercial vehicle specifically permitted for travel on such roadway by the Board of County Commissioners or the Secretary of the Kansas Department of Transportation.

Section 4. The Crawford County Road and Bridge Department is hereby authorized to post signs prohibiting the use of trucks and commercial vehicles as provided in Section 2 of this Resolution.

Section 5. It shall be unlawful for any person to operate a truck or commercial vehicle on such road, and any person found guilty of a violation of Section 2 hereof shall be subject to a fine in a sum not to exceed Five Hundred Dollars (\$500.00) for each violation.

 $\underline{Section \ 6}$. This Resolution shall be effective from and after the date of its adoption and approval.

Section 1: (a) That the maximum speed limit on 600th Avenue between 220th Street and 240th Street is hereby set at 45 miles per hour.

(b) That the maximum speed limit on 600th Avenue between 240th Street and 250th Street is hereby set at 35 miles per hour.

Section 2: The Crawford County Sign Department is hereby authorized to post speed limit signs according to the maximum speeds established in Section 1 of this Resolution.

Section 3: It shall be unlawful for any person to operate a motor vehicle on such road in excess of such maximum speed limit.


