Item One: County Clerk Lisa Lusker presented the requests for the Intellectual Disabilities Fund, Special Parks and Recreation Fund, Elderly Fund, Historical Fund and Special Alcohol fund for 2023 for the Commissioners' approval. Commissioner Moody stated that a work session was held this morning at 9:00 AM to discuss these funds and the Commissioners made their decisions on the funding amounts.

Item Two: Ms. Lusker stated that the City of Pittsburg will be holding a Special Election April 11, 2023 for the extension of the public safety sales tax. Commissioner Blair was answered that all the polling locations in Pittsburg will be open on election day.

Item Three: County Counselor Jim Emerson presented the Crawford County Annual Solid Waste Meeting, Plan Review and Summary received from Dennis Meier from Triad Environmental Services. He stated that the Annual Solid Waste Meeting was held on February 7, 2023 and explained that every year an informal review of the solid waste plan is done and every 5 years a more thorough review is done. Mr. Emerson went over the Plan Review and Summary and discussed the large item drop off held at the SEK Recycling Center on the 2nd Saturday of every month and the free day at the landfill in which Crawford County citizens are allowed one free day each month to bring their trash. Mr. Emerson stated that the City of Pittsburg and some of the other cities will be holding city wide cleanup days and discussed the county holding something similar. He also handed out an update from the SEK Recycling Center and explained the update, the shift in commodity prices and the Center's net loss for the year 2022. There was a discussion on the recycling center. He explained that is it required that the Commissioners approve this report to submit approval to KDHE to fulfill the annual review requirement.

On motion (23-084) of Commissioner Wood and the second of Commissioner Moody to approve the Annual Summary & Review of the Crawford County Solid Waste Plan for 2022.

Item Four: Commissioner Moody stated that he noticed that someone has picked up trash along 69 highway north of Arma and stated that on behalf of Crawford County he wanted to thank whomever it was for taking pride in Crawford County and let them know how much their work is appreciated.

Item Five: Commissioner Wood discussed bidding out culverts and also tracking the use of the culverts. Mr. Emerson will check on this issue.

Item Six: Commissioner Wood discussed zoned and unzoned areas in the County. Mr. Emerson explained that in the areas in the county that have no zoning, the Commissioners have no authority with what is done with the land and that county-wide zoning was attempted in the past with no success.

Item Seven: Commissioner Wood discussed new hires and physicals being required. Mr. Emerson will check into the issue.

Item Eight: Commissioner Blair discussed the active shooter training that was held at the courthouse and explained that Sheriff Smith requested that an intercom system be installed with a speaker on each floor of the courthouse. This would be a safety protocol

so announcements can be made throughout the courthouse, especially in an emergency situation.
