PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH MESSAGES FROM THE PUBLIC

Item One: Ms. Cristy Mitchell, Blue Cross and Blue Shield Representative addressed the standard benefit change for the coupon savings for prescription drugs which the State of Kansas has changed between 2019 and 2020. Ms. Mitchell explained the benefit change and stated that in 2019 the amount the member paid after the coupon was applied was the amount credited towards that member's deductible. She said that in 2020 the change was made so that the entire amount of the prescription drug before any savings were applied, is the amount credited towards the deductible. Ms. Mitchell explained that this change is state mandated on fully insured groups but self-funded groups have the option to change. She stated with this change the members would meet their deductible faster and reach the point for insurance to pay 100% sooner. Director of Fiscal Services Ms. Randi Ryan stated that in the County's group, this change is mainly only affecting the members that have an HSA. The Commissioners wanted the County Counselor to review the change.

MESSAGES FROM OTHER GOVERNMENTAL ENTITIES MESSAGES FROM APPOINTED OFFICIALS

Item One: Mr. Tim Mikrut, 911 Director, presented an Agreement and Authorization for Construction Work from Heartland Rural Electric Cooperative for Crawford County 911 Services for the relocation of an electric line in the amount of \$4,610.26. Mr. Mikrut explained the reason for the relocation and stated that this work is for the communications tower on Gooding Road. He stated that the Road and Bridge will dig the trench to save money.

On motion (20-093) of Commissioner Moody and the second of Commissioner Johnson to approve the Agreement and Authorization for Construction work from Heartland Rural Electric Cooperative for Crawford County 911 Services for the relocation of an electric line in the amount of \$4,610.26 on a communications tower.

Item Two: Mr. Mikrut presented a work estimate from Tyler Costantini for removing unused antennas from water towers at Bone Creek, Brazilton and Walnut in the amount of \$2,000.00. Mr. Mikrut explained that the antennas were placed on the towers by the County and are no longer used.

Item Three: Mr. Bill Towery, County Sanitarian discussed the proposed tire collection program and stated that even without state funding the county will need the state's approval to conduct this program. He suggested 2 pickup locations, one at the Road & Bridge District #3 Barn on the bypass in Pittsburg and one at the Fairgrounds in Girard with both being held on the same day. He reported that he spoke to Champlin Tire Recycling and they will pick up and haul off the tires for \$160 a ton. Mr. Towery will continue to work on this program and keep the Commissioners informed.

Commissioner Johnson asked Mr. Towery about the Lagoon at the SEK Humane Society. Mr. Towery stated that he has not checked recently but Road & Bridge District #1 Foreman Bill Kavanagh is going to clear out some trees but the rains have been an issue.

MESSAGES FROM ELECTED OFFICIALS PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

Item One: Commissioner Blair presented the Crawford County Local Road Safety Plan and stated that the roads are ranked in order from highest risk factor to lowest risk factor. He said that the Commissioners will need to choose 2 projects and the funding will be for 2021. The Commissioners discussed this plan and decided to readdress this issue on Friday and would like Asphalt Foreman Randy Chiartano to attend.

OLD BUSINESS:

Item One: County Clerk Don Pyle addressed the Grant Township Board and stated that two of the officers have passed away recently and the only remaining officer is new to the board. The remaining board member is working on finding individuals interested in taking over these positions and the new offices will need to be appointed by the Commissioners.

Item Two: The Commissioners discussed the distribution of the 2020 Elderly Fund. The Commissioners stated that they would like to give all the organization the money they are requesting but the funds are not available for that. The Commissioners also discussed requiring the organizations that request Elderly, Historical, Parks and Recreation and Special Alcohol Funding to submit more information starting in 2021. Commissioner Johnson stated that he would like detailed information on how the requested funds will be used and the number of individuals the organization serves. Commissioner Blair also suggested the organizations that request a large amount of money, speak to the Commissioners about their requested funds.
