The Crawford County Board of Commissioners met pursuant to Kansas Statutes

Commissioner Carl Wood served as the presiding officer.

Commissioner Tom Moody was in attendance.

County Clerk Don Pyle and County Counselor Jim Emerson were seated with the Board.

Chairman Wood led the pledge of allegiance.

MESSAGES FROM THE PUBLIC MESSAGES FROM OTHER GOVERNMENTAL ENTITIES

Item One: Ms. Julie Smith, Girard Chamber of Commerce Director addressed the Commission in reference to the sign that was removed from the Emergency Management Building lawn. Mr. Wood informed Ms. Smith that the sign was not scrapped and that it was taken to Crawford County Historical Society Museum. Mr. VanBecelaere explained why it was necessary to have the sign removed. Ms. Smith stated that there are some concerned citizens in the City of Girard that feel the sign should have remained in the City and given to the Friends of Historic Girard for the museum in Girard. Mr. Moody asked if the museum in Girard was opened and Ms. Smith stated that is was not. There was a discussion on whether the sign was on City or County property and the Commissioners requested that Mr. Emerson contact the County Surveyor Ron Albertini and have him survey the property at the Emergency Management Building. There was a discussion on how to solve the issue. Ms. Smith stated that she feels the issue can be settled with communication. The Commissioners stated that they would like to speak to the Mr. Chris Weiner, Girard City Administrator. Mr. Wood contacted Mr. Weiner and asked to come to the meeting. It was decided to continue on with new business and will readdress this issue when Mr. Weiner appears.

PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

Item One: County Clerk Don Pyle stated that he was contacted by State Representative Adam Lusker. He said that Mr. Lusker stated that there will be a hearing in Topeka on Tuesday on a bill to make it possible to open Camptown and that he would like the Commissioners to send a letter in support of the bill from Crawford County. It was decided that Mr. Emerson will work with Mr. Pyle in drafting a letter of support. Mr. Emerson will contact our lobbyist Bill Brady and have him attend the hearing. Mr. Pyle will contact Mr. Lusker and see if he will be in Pittsburg this afternoon and if so, he will hand deliver the letter to Mr. Lusker.

Item Two: County Clerk Don Pyle presenting the January 2017 Clerk's Report. Mr. Pyle stated that this report summarizes the total amounts spent by departments for payroll and bills during the month of January. Mr. Pyle also gave the Commissioners a copy of the December 2016 to January 2017 Clerk's Report of Changes in Expenditures for comparison. Mr. Pyle reviewed the changes with the Commissioners and discussed some of the reasons for the changes. Mr. Pyle also stated that the months of January and February are hard to analyze since many annual expenses are paid in January.

On motion (17-046) of Commissioner Moody and the second of Commissioner Wood to approve the January 2017 Clerk's Report as presented.

Item Three: Mr. Wood stated that the Regional Solid Waste Authority has not been active for some time and Mr. Emerson stated that it has been dissolved unofficially. Mr. Emerson stated that he could hold one more meeting and at that meeting vote to dissolve. There was a discussion in planning a meeting of the Regional Solid Waste Authority.

Item Four: Mr. Wood discussed a roller that he viewed. The Commissioners discussed the roller and agreed to purchase it.

MESSAGES FROM OTHER GOVERNMENTAL ENTITIES continued.

Item One continued: Mr. Chris Weiner, Girard City Administrator, regarding the issue of the sign removed from the Emergency Management building. Mr. VanBecelaere explained what took place to Mr. Weiner. Mr. Weiner stated there is interest in keeping the sign in Girard but he has not yet had an opportunity to speak with the officers of the Friends of Historic Girard. Mr. Moody stated that he would like any questions on the issue to come directly to the Commissioners. Mr. Wood stated that a lot of work needs to be done to the sign to bring it back to its original state. He said that there are several layers of paint that need to be removed. Mr. Wood stated that it would be beneficial for all the Museums in the County to work together. The Commissioners informed Mr. Weiner that the County Surveyor will survey the property. The Commissioners and Mr. Weiner agreed that if everyone works together there will be a solution to the problem without any problems.

UNDER THE HEADING OLD BUSINESS

Item One: Mr. Pyle stated that he spoke with Ms. Pam Mendicki at Ryan Insurance Agency about the insurance on some of the County buildings. He also stated that Ryan Insurance was checking on raising the work comp limits for the County. Mr. Pyle will have the information ready on Tuesday. Mr. Pyle and the Commissioners discussed insurance coverage for other county entities and being reimbursed for the premiums.
