Item One: Commissioner Bruce Blair regarding a review of roads in the county that could qualify for the Rural Roads Safety Grants Program through KDOT that can help to pay for safety improvements to major county roads. Mr. Blair stated this had been used to help pay for improvements to 200th Street a couple of years ago and that the state had identified a couple of other roads in the county that could qualify for that program. The commissioners agreed that they should look at those other roads.

Item Two: Commissioner Tom Moody regarding the bidding out of trash service for the county buildings that use those services. Mr. Moody was answered that nearly all of the locations have been identified and that the list of locations should be complete soon.

There was also a discussion of having a countywide cleanup program in the spring and if any progress has been made on coordinating a tire collection as part of that. Mr. Blair thought that Farm Bureau was sponsoring an event in May and the county could be part of that. Mr. Blair mentioned that the landfill being closed on Saturday could have an impact on that kind of event and this could be addressed in the new landfill agreement.

Item One: Commissioner Jeremy Johnson regarding the review of applications for the County Zoning Director position. Mr. Johnson suggested that they have an executive session before the regular meeting on Friday to review the applications and narrow the applicants that would be asked for an interview. The commissioners agreed that they would start the meeting on Feb. 7 at 9:00 AM and immediately go into executive session for non-elected personnel and then reconvene the regular session at 10:00 AM.
