#### UNDER THE HEADING NEW BUSINESS PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH MESSAGES FROM OTHER GOVERNMENTAL ENTITIES MESSAGES FROM THE PUBLIC

**Item One:** Mr. Jim Zibert, Earle's Engineering & Inspection addressed the Commissioners regarding Crawford County Sewer District #3 Force Main Relocation Project. Mr. Zibert discussed the Contractor's Application for Payment No. 1 from Heck & Wicker, Inc. He stated that this application is for 2 weeks of work which he feels was a lot of work done in a 2-week period. Mr. Zibert answered Commissioner Moody that the contractor has approximately 54% of the project complete at this time. Mr. Zibert explained where the contractor was at on the project and what will be taking place and that the project is ahead of pace. Mr. Moody thanked Mr. Zibert for his update and asked that he keep the Commissioners up to date on the project.

**Item Two:** Mr. Ray Ryan and Mr. Wally Wilson, Ryan Insurance presented the 2020 Insurance Renewal. Mr. Ryan discussed the coverage with EMC and the premium over the last 8 years compared to the claims paid over that period. Mr. Ryan reviewed the coverages and premiums and discussed the EMC Workers Compensation Pool Dividend program that has paid the county \$338,000 in dividends over the past 8 years and should be factored in when evaluating the cost of that coverage. Mr. Wilson stated that the premium for workers compensation coverage would increase slightly this year because the last year of claims that drops off for calculating the MOD this year had very low

claims and that the year that was replacing it had much more in claims. Mr. Wilson also discussed that the MOD for 2021 should be lower than this year because the year that will drop off next year had a very high amount of workers compensation claims. The package of insurance was reviewed with the Commissioners and the Commissioners thanked Mr. Ryan and Mr. Wilson for the information and for the work they do to keep premiums low. The Commissioners agreed to review the invoice for insurance coverage.
