**Item Four:** Mr. Emerson presented a notice to publish in the newspaper that the Board of County Commissioners desire to utilize the provision of the code for enforcement of county codes and resolutions. Mr. Emerson explained the details of the notice and that if 5% of all electors sign a protest petition within the 30 days the issue must be voted on by election. He also stated that after the 30 days protest period the county is given permission to move forward with codes court. Mr. Murphy was answered that the Codes Court regulations can be approved and a judge can be hired before the 30-day protest period but codes court cannot meet until the 31st day.

#### NOTICE

Notice is hereby given that the Board of County Commissioners of Crawford County, Kansas desires to utilize the provisions of the code for enforcement of county codes and resolutions as set forth in article 47 of chapter 19 of the Kansas Statutes Annotated, and amendments thereto.

If within thirty days next following the date of publication of such notice a petition, signed by electors equal in number to not less than 5% of the electors of the county, requesting an election thereon, shall be filed in the office of the county election officer, no utilization of the provisions of the code for enforcement of county codes and resolutions as set forth in article 47 of chapter 19 of the Kansas Statutes Annotated, and amendments thereto, may be made without such proposition having first been submitted to and having been approved by a majority of the electors of the county voting at an election called and held thereon.
