Item One: Mr. Pyle stated that he attended the luncheon hosted by Westar about the improvements Westar will be making in Frontenac. Mr. Pyle explained what took place at the meeting and discussed the new substation that Westar is building, where the connections will be, and where it will tie into other existing lines. Mr. Murphy was answered that it will be in the city limits of Frontenac and on property owned by Sugar Creek Packing Company in the very SE corner of Sugar Creek's property. He stated that Westar is in the progress of purchasing that property from Sugar Creek Packing. Mr. Pyle addressed the notification of adjacent property owners and that letters we required to be sent to the landowners within 200' of the proposed location. He stated that there will be an open public meeting on July 28 at Memorial Auditorium. Mr. Pyle stated that Representative Lusker asked Westar about rate increases due to the new substation and Westar answered that it is already included in the current budget.
