UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH MESSAGES FROM APPOINTED OFFICIALS

Item One: Honorable Lori A Bolton Fleming, Chief Judge of the 11th Judicial District addressed the Commissions in reference to Opioid Settlement Funds for drug court. She gave some background information on the efforts over the past years to bring drug court to the 11th Judicial District. She stated that there are now many drug courts in the State of Kansas. Judge Fleming explained that the Supreme Court has established a set of guidelines that are required to be followed and there is funding available for the startup and upkeep of drug court. She said that a task force has been created and she listed some of the participants. She explained the plans and the steps that will need to be taken to establish drug court. Judge Fleming said that the request being submitted to the Commissioners is for \$10,000 from the Opioid Settlement Funds and the money will be used to send teams out across the state to visit drug court sites. She presented the Commissioners with a travel budget. She explained to the Commissioners the purpose and the procedure of drug court. Judge Fleming stated that they have been working with Community Health to develop drug court and explained the reasons why. Commissioner Wood was answered that Crawford County Mental Health is part of the drug court team. Commissioner Blair stated that he feels that going out and visiting the other drug courts is a good way to see what would best fit the 11th Judicial District. He said he feels this is a great start and County Counselor Jim Emerson stated that this does qualify for opioid funds.

On motion (23-276) of Commissioner Wood and the second of Commissioner Moody to approve the request for Opioid Settlement Funds in the amount of \$10,000 for Drug Court as presented by Honorable Lori A Bolton Fleming, Chief Judge of the 11th Judicial District.

Mr. Emerson stated that Crawford County is the sub recipient and CTEC will be the beneficiary. He explained the matching funds and stated that when an invoice is sent in, the state will pay 90% of the invoice and CTEC will pay the rest of the invoice amount.
