Item One: Mr. Rick Pfeiffer presenting a White Paper Report on the Town Hall Meetings that were held in Girard and Pittsburg regarding the future design of addiction treatment services. Mr. Pfeiffer handed out the 4 Year Plan White Paper Report on Addiction Services 2016-2020 and did a brief presentation on the Plan. He would like the Commissioners to review the handouts and he will return to the Board on Tuesday, June 14, 2016 for further discussion and to answer any questions.

The Commissioners and Mr. Pfeiffer also discussed some different ways of funding construction of facilities for the project. There was a discussion of a 1 mill property tax levy to be used for this in conjunction with the issuance of bonds for construction.

Item Four: Mr. Emerson handed the Commissioners copies of the statutes on financing public buildings and he discussed the statutes with the commissioners. Mr. Emerson stated the Commissioners can review these statutes and he would answer any questions that they have. Mr. Murphy was answered that this type of financing would be exempt under the new tax lid law.

Item Five: Mr. Murphy reported on the latest Economic Development Committee meeting which was held on June 6 at the Pittsburg Area Chamber of Commerce offices. Mr. Murphy stated that the meeting went very well and that representatives from SEK Inc and Pittsburg State University were in attendance. He stated that the committee created 3 focus areas, work force development, housing and supporting existing businesses and developing new businesses. Mr. Murphy said that Dick Horton was elected Chairman of the committee. He stated that the next meeting will be June 27, 2016 at Horizon Systems in McCune.

Item Six: Mr. Murphy addressed the Live Well Meeting on June 10, 2016 at 6:00 PM at the Girard Civic Center. He stated that the meeting will focus on county wide bicycle and walking trails in Crawford County. Mr. Murphy stated that he spoke to Liz Hart, Randy Chiartano and Mike Plank about taking part and they all agreed to attend this meeting.

Item Seven: Mr. Murphy addressed houses in poor condition in the County and how to demolish the structures. There was a brief discussion of some of the steps that must be taken before demolition of a structure can take place.

Item Eight: Mr. Murphy stated that he has been reviewing the department budget requests and would like to set up work session with a few of the department heads. Mr. Murphy will set up the work sessions and inform Mr. Pyle as to when the sessions will be held.

Item Nine: Mr. Wood addressed the current contract with Employee Screening Services of Missouri, LLC now known as Tomo Drug Testing. Mr. Emerson stated that after making the motion to cancel the contract there is a 90 day out and it will be the 4th quarter before we can start using Via Christi Occupation Health for CDL and random drug and alcohol testing.
