PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS CRAWFORD COUNTY BOARD OF HEALTH MESSAGES FROM APPOINTED OFFICIALS MESSAGES FROM OTHER GOVERNMENTAL ENTITIES

**Item One:** Mr. Kevin Cowan with Gilmore & Bell, bond council for Girard Medical Center spoke in reference to the refinancing of bonds issued in 2009. Mr. Cowan

explained that refunding the bonds with lower interest bonds is the reasoning for doing this. He stated that a refinancing will result in a new payment schedule that will lower payments. He stated the only formal action needed from the Commissioners is adopting a resolution authorizing the supplemental documents and move forward with the refinancing. Mr. Emerson stated he has reviewed the documents and has no issues with it. Mr. Cowan stated that the anticipated closing is on March 30, 2016. Mr. Cowan presented Resolution #2016-007, a Resolution authorizing Crawford County, Kansas to enter into a supplemental lease with option to purchase No. 1, dated March 30, 2016 which supplements a lease with option to purchase between the County and the Crawford County, Kansas Public Building Commission, dated September 9, 2009 whereby the County will continue to lease from the Public Building Commission certain property, and to enter into a supplemental sublease No. 1 with Hospital District No. 1, Crawford County, Kansas, which supplements a sublease, dated September 9, 2009, whereby the County will continue to sublease such property to Hospital District No. 1, Crawford County, Kansas; approving the form of said supplemental lease with option to purchase No. 1 and supplemental sublease No. 1; and authorizing the execution thereof and certain related documents.

On motion (16-102) of Commissioner Murphy and the second of Commissioner Moody to adopt Resolution #2016-007, a Resolution authorizing Crawford County, Kansas to enter into a supplemental lease with option to purchase No. 1, dated March 30, 2016 which supplements a lease with option to purchase between the County and the Crawford County, Kansas Public Building Commission, dated September 9, 2009.

### **MESSAGES FROM THE PUBLIC**

**Item One:** Mr. Murphy said that he requested that the City of Pittsburg speak with the Commissioners about the changes the City has made in their health and dental insurance coverage for their employees. Mr. Daron Hall, City Manager and Mr. Jamie Clarkson Finance Director for the City of Pittsburg stated that they had stepped away from Blue Cross and Blue Shield and bid out the insurance to save money. Mr. Hall stated that the City looked at a 5 year financial forecast and the biggest cost center was the employees. Mr. Hall stated that they had been with Blue Cross/Blue Shield for over 50 years but for financial reasons had to step away. Mr. Hall stated that they did not want to decrease benefits but did want better rates. Mr. Hall state they had the Gallagher Group come in and other consultants and talk about the options the city had with their health insurance and they decided to bid out for a health insurance provider. Mr. Clarkson stated that the City is still self-insured and still pay their own claims. Mr. Hall and Mr. Clarkson explained how the change took place and the outcome of the change and answered all the Commissioner's questions. There was a discussion about the rates and deductibles and what the City's employees have to pay for their coverage out of their pocket. Mr. Hall and Mr. Clarkson explained that they have 5 separate companies to administer their benefits, Truss Advantage is the consultant, Core Source is the 3<sup>rd</sup> party administrator,

HST is the claims processor, ProviDRs Care is the providers network, Delta Dental is the Dental insurance and MedTrax is the Pharmaceutical Insurance and each one of these aspects were bid out separately. They also discussed programs they implemented to try and keep health care costs down. The Commission thanked Mr. Hall and Mr. Clarkson for talking with them and for their input.

Mr. John Chalafant from Gallagher Group answered the Commission that the County could bid out the county insurance and in his opinion thinks the county could save money. He stated that the bidding process would need to start soon. Mr. Wood discussed educating County employees on the coverage they currently have with the insurance. Mr. Rick Pfeiffer spoke about the benefits to County employees using the Health Department, Mental Health Department and the Drug and Alcohol assessing. Mr. Chalafant stated that he will get back with the Commissioners.
