Item One: County Clerk Lisa Lusker asked the Commissioners whether the courthouse will be closed on Friday, April 15th, 2022 in observance of Good Friday. Commissioner Moody stated that this has been the case historically. All commissioners agreed that the courthouse will be closed on Friday, April 15th, 2022. Ms. Lusker also reminded the commissioners that they still need to schedule a work session with Mr. Kyle Nelson with GIS to discuss redistricting. Commissioner Johnson said he had spoken with Mr. Nelson and County Councilor Jim Emerson, and plan to schedule the meeting for the first full week of April. Ms. Lusker also told the commissioners that Ms. Christy Mitchell with Blue Cross would like to schedule a work session to discuss changes in the new policy

year. A meeting was tentatively scheduled for April 8th, 2022 at 9:30 am. Ms. Lusker also discussed with the commission a proposal to switch gas service from a 3rd party provider back to direct purchasing from Kansas Gas Service. The commissioners asked Ms. Lusker to handle the paperwork involved in getting switched over and she agreed.

Item One: Commissioner Blair discussed the low water bridge repair project. He received a bid from a company that uses rail cars as bridges. The commission decided this would be the most economical route.

On motion (22-122) of Commissioner Blair and the second of Commissioner Moody to approve the purchase of a 30 foot rail yard car for \$27,000 from The Railroad Yard, Inc. Yeas: Commissioners Moody, Blair and Johnson Nays: Present but not voting: Absent or not voting: **The motion prevailed.**

Item Two: Commissioner Blair stated that the Caterpillar compactor the county purchased is scheduled to be delivered tomorrow, March 30th.

Item Three: Commissioner Johnson said he had spoken with Lauren Mattingley in the Fiscal Office regarding the job description project and Ms. Mattingley has received 11 departments' responses so far. Commissioner Blair stated he will work on getting the Road and Bridge Department finished up. Commissioner Moody stated he would like all three road foreman to sit down together to collaborate on the job description project.
