**Item Two:** Ms. Lusker discussed the SEK Officials meeting which is being hosted by Anderson County and will be held at the Anderson County High School in Garnett, KS on Thursday, March 17, 2022. The Commissioners stated that they will be unable to attend. County Counselor Jim Emerson stated that he should be able to attend.

**Item Three:** Mr. Emerson addressed ARPA funding for the City of Arcadia. He handed out a breakdown of the requested funds from the City of Arcadia. He stated that County Grant Writer Gus Brunetti has been working with Arcadia City Clerk Linda Morris on the requested funds and is going to work with her in the future on possibly obtaining CDBG funds for some of the infrastructure repairs. Mr. Emerson explained that the City of Arcadia qualifies for \$75,000 based on the formula used for other cities by population.
