UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: The Commissioners were presented with the Crawford County Gating Criteria updated Friday, May 28, 2021. Deputy County Health Officer Ms. Teddi Van Kam reviewed the community gating criteria and discussed the new positive cases for the week and the weekly percent positivity rate. She also discussed school K-12 Gating Criteria and stated that officially all the schools were out by Tuesday for the summer. She said that the school year ended on a very good note. Ms. Van Kam discussed vaccination statistics and clinics as well as COVID-19 immunizations for children 12 and over.

Ms. Van Kam stated that today is Ms. Janis Goedeke's last day and she wanted to publicly thank her for coming back after her retirement and stepping in and for all her guidance during this pandemic and she was truly a godsend. Ms. Goedeke said it was so nice to be able to speak to the Commissioners on her last day without a mask. She thanked the Commissioners for allowing her to come back and serve her community and that it has been a wild ride and it is something that will go down in history. She discussed her experiences during this pandemic and how the community and schools came together. Commissioner Moody thanked Ms. Goedeke, Ms. Van Kam and Mr. Michael Ehling for their hard work in protecting the community during this pandemic. Mr. Ehling spoke about Ms. Goedeke stepping in and taking over as Health Department Director and he thanked Ms. Goedeke for her hard work and wished her well in her retirement.

PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE PUBLIC MESSAGES FROM ELECTED OFFICIALS MESSAGES FROM OTHER GOVERNMENTAL ENTITIES MESSAGES FROM APPOINTED OFFICIALS

Item One: Mr. Michael Ehling, Executive Administrator addressed the Commissioners in reference to the Mental Health Financial Report. He stated that attorney Mr. Mark Werner, who is the legal counsel for the governing board, will speak about the statute driven responsibilities and FACT, Inc. Mr. Ehling said that Mr. Daryl Eagon, CPA, their auditor, will address the financial audits. He also introduced Ms. Joanie Burke, SEK CAP Senior Associate and Director of Early Childhood Services and Ms. Heather Spaur, Director of Personnel and Marketing and CFO. Ms. Spaur handed out the Community Mental Health 2020 Budget, the Community Mental Health 2021 Budget, the April 2021

Monthly Financial Statement, the KSA Statutes on the creation of CMHCs across the State, the FACT, Inc. bylaws and the 2019 Crawford County & Mental Health Audit. Mr. Ehling explained that Mr. Eagon is actively working on the 2020 Audit and a copy of the audit will be sent to the County Clerk each year.

Mr. Werner explained the statutory requirements for community mental health centers in the State of Kansas. He stated that in 1961 community mental health centers were statutorily authorized and Crawford County was one of the first to create a mental health center. He explained the Quasi-Governmental Entity. He explained the statutes that detail how the centers are to be governed. He also explained the sources of revenue for the center to operate. Mr. Werner discussed FACT, Inc, a 501c3 and stated it is a separate private not for profit corporation and it is not part of the Mental Health Center but was created by the Mental Health Center. He explained the reasons for creating the FACT, Inc., the main purpose and the main source of funding. He explained the bylaws of the corporation. Mr. Eagon stated that the corporation must file a form 990 tax return with the IRS each year and that the form must be available to the public by law.

Ms. Burke addressed the Commissioners and explained the Options program and the partnership between SEK CAP and the Community Mental Health Center.

Mr. Eagon addressed the Commissioners and explained GAAP. He also addressed the financial statements and audits. Commissioner Johnson asked about the new Addiction Treatment Center and the financial status of the center and Mr. Ehling explained the crisis stabilization unit and the redesign of the center. He spoke about the estimated costs of the building and equipment and the sober living apartments. He stated that they are still working with the architect so they do not have a final number on the costs. Mr. Ehling stated that right now the committed amounts for the ATC are the \$1,000,000 from the ½ mill that was set by the Commissioners 5 years ago, \$1,800,000 from FACT, Inc., \$300,000 grant from Sunderland, \$100,000 donation from the Elliott Foundation, \$55,000 from private donations and fund raising, \$50,000 from the Bicknell Family Foundation and \$45,000 from the Skubitz Foundation. There was a discussion of the prepaid rent on the building. There was also a discussion of goals and priority areas for the future. Commissioner Johnson discussed pay disparity in Mental Health. There was a discussion on Mental Health and the needs in Crawford County. The Commissioners thanked Mr. Ehling, Mr. Werner, Mr. Eagon and Ms. Spaur for their presentation.

On motion (21-168) of Commissioner Johnson and the second of Commissioner Moody to recess this open session for a period of 5 minutes.

He explained what the procedure will be in the following years in going through this process.
