Commissioner Bruce Blair served as the presiding officer.


Commissioners Tom Moody and Jeremy Johnson were in attendance.

Chairman Blair led the pledge of allegiance.

UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD

Item One: Chairman Blair presented a Proclamation proclaiming Friday, June 29, 2020 as Kansas Army National Guard 891st Battalion Day in Crawford County, Kansas. Chairman Blair read the proclamation.

UNDER THE HEADING NEW BUSINESS continued MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: County Health Officer Rebecca Adamson addressed the Commissioners regarding the COVID 19 outbreak. She stated that the Governor put forth a new disaster declaration and the executive order was not renewed with the new declaration. She explained that as of Monday, May 25 at 12:01 AM Crawford County is not under any legal order. She said that she would like the Board of Health to adopt the "Kansas Ad Astra: A Plan to Reopen KANSAS" to be the Crawford County plan as a recommendation to the citizens and businesses in the County. Ms. Adamson explained that this would be a recommendation only and Crawford County would have no legal plan in place. She stated that all the businesses she has spoken to plan to continue following Phase 2 of the plan and most of the surrounding counties are using Phase 2 as a suggestion and are not putting a legal order in place. Ms. Adamson stated that Phase 3 is scheduled to go into effect on June 8, 2020. She explained that at this time bars &

nightclubs and public swimming pools can be opened if they wish and that fairs, parades and ball games can be held. She stated that by using common sense and following basic guidelines we can protect each other. She explained what would take place if an outbreak should happen. She explained that the 4 metrics, death rate, health care systems ability to handle the load, our ability to test and our ability to trace, isolate and quarantine is how will we decide if changes need to be made. She discussed testing and supplies.

On motion (20-227) of Commissioner Moody and the second of Commissioner Blair to adopt the "Ad Astra: A Plan to Reopen KANSAS" as the recommendations for reopening Crawford County.

Ms. Adamson stated that she is a member of the Crawford County Recovery Task Force that was started by Shawn Naccarato and stated who some of the other members of the task force are. She explained that she would like a central point to put out information to the citizens of the county and would like to use the County Website. County Clerk Don Pyle stated that the information should be sent to Brandon Spaur in the IT Department as a direct link to the website and suggested the information also be sent to him. She explained what the task force will be doing.

Item Two: Mr. Michael Ehling, Crawford County Mental Health Executive Administrator stated that the Addiction Treatment Center has been re-opened and is accepting clients. He explained that the Challenger Program will start on Monday, June 1, the Discovery Program has been operational for 2 to 3 weeks, and the lobbies at the Mental Health Center have been reopened.

County Counselor Jim Emerson discussed the current procedure at the Courthouse and he feels it is okay to end the screening process and to change the hours from 8:00 AM to 4:00 PM for a couple of weeks and then change back to normal hours of 8:00 AM to 4:30 PM. He stated the Motor Vehicle at the Judicial Center in Pittsburg will remain closed at this time. The Commissioners and Mr. Emerson thanked Ms. Adamson for allowing an employee of the health department to conduct the screening process the last few weeks. It was decided that starting Monday, June 1, 2020 to no longer do a screening process or a log in process at the entrance and to change the hours to 8:00 AM to 4:00 PM.

Undersheriff Scott Tyrell stated that the drive through VIN Inspection will be ending today and on Monday it will be done through the lobby at the jail. He explained that they will also be allowing some inmate visitation and the employees will still do self-checks when coming into the building.

Ms. Adamson stated that the employees at the Health Department will still have their temperature taken before entering the building.
