Girard, KS Friday, November 17, 2017, immediately after the meeting of the Board of County Canvassers

The Crawford County Board of Commissioners met pursuant to Kansas Statutes.

Annotated Chapter 19, Article 2, Section 18 in due and regular session with open doors.

Commissioner Carl Wood served as the presiding officer.

Commissioners Tom Moody and Jeff Murphy were in attendance.

County Clerk Don Pyle and County Counselor Jim Emerson were seated with the Board.

Chairman Wood led the pledge of allegiance.

UNDER THE HEADING NEW BUSINESS PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE COUNTY LOCAL BOARD OF HEALTH MESSAGES FROM APPOINTED OFFICIALS

Item One: Mr. Rick Pfeiffer, Executive Director and Ms. Heather Spaur, Director of Personnel and Marketing, Crawford County Mental Health presenting Mental Health Advocacy Award. Mr. Wood presented the award to Mr. George Shoemaker. Mr. Pfeiffer stated that this is the 1st Mental Health Award and this award will be put on display in the Commission Room. Mr. Shoemaker expressed his appreciation for the award.

MESSAGES FROM THE PUBLIC

Item One: Representative Monica Murnan gave an update on the legislative session. She stated that a comprehensive tax policy was passed which put a few more dollar in the schools but did not include Medicaid expansion. She said that she has 3 main focuses and explained the focuses to the Commissioners. She explained that the 1st focus is on budget and tax reform, 2nd focus is on school funding and the 3rd focus is Medicaid expansion. Ms. Murnane stated that she would like to hear from anyone with concerns and she will be happy to speak with them. Mr. Murphy addressed mental health and state hospitals and juvenile detention and rule changes. The Commissioners and Ms. Murnane discussed Highway 69 in Crawford County.

Item Two: Representative Adam Lusker praised Ms. Murnan and the work she does in the legislature. He discussed the schedule in the legislative session. He explained the tax bill passed in 2012 and why the tax bill was passed and what the effect it has had over the last few years. He also spoke about the welfare system in Kansas. The Commissioners and Mr. Lusker discussed private industry. Mr. Lusker also spoke about T-Works projects and 69 Highway. Mr. Lusker stated how well Mr. Bill Brady works with the legislator and how informed Mr. Brady is. He spoke about Governor Brownback leaving and Lieutenant Governor Colyer taking over.

The Commissioners thanked Representative Murnan and Representative Lusker for coming today.

Item Three: Mr. Bill Brady, Capitol Strategies stated this is the 3rd year working with Crawford County as their lobbyist. He spoke about Lieutenant Governor Jeff Colyer. He also spoke about the candidates that are running for governor. He talked about what will be addressed in the upcoming legislative session and the main concerns. Mr. Brady and the Commissioners discussed the mental health issues and the juvenile detention issues. Mr. Rick Pfieffer also spoke about the Mental Health issues in the County and State.

Item One: Ms. Johanna Winter, Girard City Administrator introduced herself to the Commission.

MESSAGES FROM ELECTED OFFICIALS PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

Item One: County Counselor Jim Emerson presented Resolution#2017-029, a Resolution terminating Crawford County's participation in the Southeast Kansas Solid Waste Authority and the Unanimous Consent Resolution. He stated that the Southeast Kansas Waste Authority was started in the 1990's and over the years grant monies have fallen off so no projects have been done. Mr. Emerson explained that the State recommended dissolving the regional authority but Crawford County will remain responsible at the county level. He said that each county in the regional authority will need to approve and sign the Unanimous Consent Resolution.

RESOLUTION 2017 - 029

A RESOLUTION TERMINATING CRAWFORD COUNTY'S PARTICIPATION IN THE SOUTHEAST KANSAS SOLID WASTE AUTHORITY

WHEREAS, Crawford County currently participates in the Southeast Kansas Solid Waste Authority (SEK SWA) along with other counties; and

WHEREAS, Crawford County and the other participating counties desire to dissolve the SEK SWA and maintain their solid waste programs individually on a county by county basis;

NOW THEREFORE, be it resolved by the Board of County Commissioners as following:

That Crawford County does hereby terminate its participation in the SEK SWA and consents to its full dissolution. It is further resolved that the Unanimous Consent Resolution attached shall be signed by the Chairman and submitted to KDHE.

UNANIMOUS CONSENT RESOLUTION

The undersigned, being all of the Directors of Southeast Kansas Regional Solid Waste Authority, Inc. ("Regional Authority"), do hereby unanimously consent to the action set forth in the resolutions below. This Consent is adopted in lieu of holding a special meeting of Directors and by signing this Consent, the undersigned Directors do hereby waive any requirement for such meeting or notice thereof.

The following resolutions are adopted:

WHEREAS, the Regional Authority was formed pursuant to an Interlocal Agreement and General Plan for Solid Waste Management adopted <u>DATE</u>, ("Interlocal Agreement") by the Regional Authority Members, being Allen, Bourbon, Cherokee, Crawford, Labette, Neosho, Wilson, and Woodson Counties in Kansas; and

WHEREAS, pursuant to the Interlocal Agreement, the Counties established a not-for-profit corporation known as the Southeast Kansas Regional Solid Waste Authority, Inc., which was duly organized on <u>DATE</u>, by the filing of Articles of Incorporation with the Kansas Secretary of State; and

WHEREAS, thereafter in furtherance of the Interlocal Agreement the Regional Authority, created a Regional Solid Waste Management Committee, adopted By-Laws, and elected Directors for the Regional Authority; and

WHEREAS, since said time, the Regional Authority has acted on behalf of all of the Counties with respect to solid waste management matters, including initial efforts to create a Regional Solid Waste Landfill for the use by all of the Counties; and

WHEREAS, subsequent to initiating efforts to create a Regional Solid Waste Landfill, changes in regulations by the Kansas Department of Health & Environment ("KDHE") made it more practical and possible for the separate Counties to maintain their own landfills thereby eliminating the necessity for a Regional landfill; and

WHEREAS, the requirements of KDHE for regional solid waste organizations require annual and other periodic filings and plans creating significant amounts of work on behalf of the Region that are no longer of any significant or material benefit to the Counties because most of their solid waste efforts are done on a localized basis or through cooperative agreements with third parties that don't require Region approval; and

WHEREAS, KDHE has indicated to the Regional Authority that it would be acceptable to KDHE for it to disband as a Region and thereafter to comply with KDHE rules and regulations with respect to solid waste management on a county by county basis which will be simpler and more cost effective to each of the Counties; and

WHEREAS, each of the Counties acting by and through their Board of County Commissioners have adopted resolutions authorizing the termination of the Interlocal Agreement and directing that the Regional Authority be dissolved.

NOW, THEREFORE, BE IT RESOLVED by the Directors of the Regional Authority and as authorized and empowered by the Interlocal Agreement and the Counties that the Regional Authority should be and hereby is voluntarily dissolved by the unanimous written consent of its Directors effective the date signed by the last Director.

BE IT FURTHER RESOLVED, that all expenses due and owing by the Regional Authority should be paid in accordance with the terms of the Interlocal Agreement.

BE IT FURTHER RESOLVED, that all assets belonging to the Regional Authority should be liquidated and distributed in accordance with the Interlocal Agreement, the actions of the Regional Authority and its By-laws as soon as practicable.

BE IT FURTHER RESOLVED, that ______, as its President, is hereby appointed as representative of the Regional Authority for the purpose of making all filings necessary to effectuate the dissolution of the Regional Authority and to do all other things reasonably necessary to complete the dissolution and liquidation and all such actions may be taken by him without the necessity of further authorization or consent by the Directors; provided, all payments made for expenses, all sales of assets of the Regional Authority, and all distributions of funds to the respective County members shall require action of the Directors in accordance with the By-laws.

BE IT FURTHER RESOLVED, this Unanimous Consent Resolution may be signed in counterparts by the Directors and proof of the execution of this Unanimous Consent Resolution may be made by the forwarding of an electronic or facsimile copy by any Director to Jim Emerson; jime@ckt.net.

BE IT FURTHER RESOLVED, that a copy of this Unanimous Consent Resolution, together with the signatures of all Directors shall be placed and held in the Regional Authority's records.
