He stated that this description was included in the publication and the public hearing but was inadvertently left off the original resolution.

Mr. Emerson explained that normally the Sheriff's Department keeps the bids local but this year the 2 local dealers were unable to provide bids due to the shortage of vehicles and one dealer stated that delivery could be from 3 months to a year. He stated that Sheriff Smith located a dealer, Superior Emergency Vehicles from Andover Kansas, that have the vehicles in stock and presented a bid from this dealer for 3 2021 Dodge Durangos that include all equipment and installation. There was a discussion on the trucks that are listed as trade ins. Mr. Emerson asked that he be allowed to look for lease purchase financing.

He presented a letter to KDOT requesting lighted, blinking stop signs be installed at this intersection and the letter also states that the county is willing to partner financially with KDOT to resolve this issue.
