#### UNDER THE HEADING NEW BUSINESS

PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE COUNTY LOCAL BOARD OF HEALTH MESSAGES FROM THE PUBLIC

Item One: Ms. Edra Meyer representing Miners Hall Museum discussed the Wine Walk & Camp Talk that will be held in Franklin on Friday, October 20, 2017. Ms. Meyer informed the Commissioners that she is in charge of the walk. She explained what will take place that evening. She stated that the one station will be at the Miner's Hall Museum and one station will be at the Franklin Community Park and she is requesting barricades to block off part of Broadway street between those two stations. County Clerk Don Pyle explained that Broadway Street in Franklin is a state road and he has spoken to KDOT and they are fine with shutting down that portion of Broadway street for the event. He stated that he has also informed Sheriff Peak of the road closure. Mr. Pyle displayed a map of the area. The Commissioners discussed where they thought the barricades should be placed. The Commissioners and Ms. Meyer decided they will put a barricade with a flashing yellow light if possible at 8<sup>th</sup> street and a barricade at 7<sup>th</sup> Street on Broadway. Commissioner Moody stated that he will make sure the barricades are at that area on Friday before the walk begins.

Item Two: Mr. Matt Sanders, WCA Oak Grove Landfill addressed the landfill. Mr. Sanders discussed a tipping fee increase for 2018 of \$1.50 per ton. He explained that this increase will go into effect January 1, 2018. He stated that the tipping fee is currently \$41.50 per ton and the increase would make it \$43.00 per ton plus a \$3.00 host fee. Mr. Sanders said that the last increase was in January 2015. He also stated that this fee is still competitively lower than other landfills around. Mr. Sanders stated that most of the local haulers are contracted and this increase will not affect them. Mr. Wood stated that he is concerned that the county does not see any money from the increases and that is due to the contract but the county is spending a lot of money on the landfill road. Mr. Sanders discussed the haulers and other landfills. Mr. Emerson stated the contract between Crawford County and WCA is up in 2018. Mr. Sanders stated that he would like better road maintenance on 700<sup>th</sup> Ave and Mr. Moody stated that issue will be addressed when the contract is negotiated. Mr. Wood would like an executive session with Mr. Sanders.

Mr. Emerson will set it up. Mr. Sanders answered Mr. Murphy that he employees 9 people and receives about 65 trucks per day but more transfer trucks and larger trailers. He also discussed the power plant.

MESSAGES FROM OTHER GOVERNMENTAL ENTITIES MESSAGES FROM ELECTED OFFICIALS PROCLAMATION AND ORDERS OF THE BOARD NEW BUSINESS

**Item One:** Mr. Pyle stated that he spoke to Dr. Sullivan and set up a tour and information session at Dr. Sullivan's facility on Friday, October 20, 2017 at 230 PM. He stated that he has sent the Elected Officials and Department Heads emails inviting them to attend this session.

**Item Two:** Mr. Murphy addressed purchasing a pickup truck for his road district to replace a truck that has the frame totally rusted out. He had Mr. Pyle show a 2009 Ford F150 regular cab 4 wheel drive pickup on Bitner Motor's Website that he is interested in. He stated that the vehicle has 114,00 miles and the asking price is \$11,900. Mr. Murphy stated that he plans to look at the truck and also have Greg Hite look at it and negotiate a price. Mr. Murphy discussed the poor condition of 2 pickups in his road district. Mr. Moody stated he has no problem with Mr. Murphy looking into or purchasing this vehicle.

**Item Three:** Mr. Murphy discussed a rotating Limb Shear that would attach to the mini excavator to cut large branches along the roads.

**Item Four:** Mr. Moody stated he will make sure the barricades are in Franklin Friday.

**Item One:** Mr. Pyle informed the Commissioners that ballots for the 2017 City/School General Election will be mailed tomorrow and also advanced voting begins on that day in the County Clerk's Office. He also stated that the voter registration books will close today at the end of the business day.

**Item Two:** Mr. Emerson addressed the conflict of interest policy and the Commissioners decided to readdress this on Tuesday.

**Item Three:** Mr. Murphy addressed the purchase of the pickup truck for his district.
