Item Four: Mr. Emerson handed out a Kansas Department for Children and Families Grant Application for RJA for the Truancy Intervention Program. He explained that the grant is for \$504,266.56 and if successful it will continue to allow RJA to provide truancy services. He also stated that the truancy services were previously funded from a grant through the State of Kansas but it was found out in June 2023 that the grant would no longer be funded. Mr. Emerson explained that RJA has since been using ARPA funding to run the program for the remainder of this year and if they can obtain the grant then the county would benefit from this significantly. Commissioner Wood asked how long this grant funding would last and Mr. Emerson stated to his knowledge this grant could be eligible for up to 3 years. He explained it would be initially for 1 year and then eligible for renewal for up to 2 additional years.

On motion (23-401) of Commissioner Moody and the second of Commissioner Wood to approve the Kansas Department for Children and Families Grant Application for RJA for the Truancy Intervention Program in the amount of \$504,266.56 and authorize the Chairman to sign.

As far as lodging they discussed having 2 employees per room.
