UNDER THE HEADING NEW BUSINESS PROCLAMATION AND ORDERS OF THE BOARD MESSAGES FROM CRAWFORD CO LOCAL BOARD OF HEALTH

Item One: County Health Officials with COVID-19 update. The Commissioners were presented with the Crawford County Gating Criteria updated 9/25/2021. Dr. Tim Stebbins and Teddi Van Kam addressed the Commissioners stating that the county's new case count has decreased and hospital capacity is improving. There are still challenges with long-distance patient transfers, and also with staffing at long-term care facilities. K-12 schools incidence rates are improving. A meeting with area administrators is scheduled for Friday to discuss whether County Health Officials will be recommending shifting from universal masking to mask optional in schools. There have already been 6 positive tests for Influenza A in the community, and both Dr. Stebbins and Ms. Van Kam agree that getting the flu shot

is the best method of prevention. Both officials spoke about the Covid booster and the Covid vaccine for children under 12, stating that the county will follow guidelines from the KDHE. Bryan Hanson spoke to the Commissioners regarding quarantine rules. His son attends Pittsburg High School and was quarantined because of a classroom contact. Mr. Hansen had several concerns regarding how the matter was handled and Commissioner Moody suggested he consult the USD 250 Board of Education. Commissioner Blair suggested facilitating a discussion with Mr. Hanson with the Health Officials, not during a Commission meeting.

PUBLIC HEARINGS AND OPENING OF ANNOUNCED BIDS MESSAGES FROM THE PUBLIC MESSAGES FROM APPOINTED OFFICIALS MESSAGES FROM ELECTED OFFICIALS MESSAGES FROM OTHER GOVERNMENTAL ENTITIES NEW BUSINESS

Item One: County Clerk Don Pyle spoke about some mailings that have been brought to the attention of the Clerk's office. The mailings contain an application for voter registration, or for an application for advanced ballot. He stated that these mailings were not from the County Clerk, nor were they affiliated with the County. Mr. Pyle wants the public to know that they can contact the office at anytime to request information on their voter status, or to request an advanced ballot.

Item Two: County Counselor Jim Emerson stated that Blake Benson with the Pittsburg Area Chamber of Commerce requested to attend the October 1st meeting for an executive session to discuss the CVB director.

Item Three: Commissioner Blair discussed his district's mowing equipment being in repair. He asked Commissioners Moody and Johnson for their districts' help to get caught up with mowing. Commissioner Blair also requested a work session soon to discuss fall projects.

Item Four: Commissioner Moody asked County Counselor Jim Emerson how the tax sale went. Mr. Emerson stated that 32 of the properties were sold, collecting \$179,949 out of the sale. It was well attended and successful. Mr. Emerson mentioned that the property east of the County barn did not sell, and suggested the County keep the property. Commissioner Blair would like to use the property to create additional employee parking. Another tax sale is tentatively planned early in 2022, and one in the summer of 2022.

OLD BUSINESS

Item One: Commissioner Blair stated he received a cost estimate on the property the County acquired in Chicopee. The cleanup estimate was lower than previously thought, cost will be around \$5,000. Commissioner Moody suggested the project go forward.

Item Two: Commissioner Johnson spoke about attending the Girard Chamber's E Community meeting last week. He learned a lot about the program, and was impressed with the youth entrepreneur competition and revolving loan program to assist with businesses.
