Item Three: Mr. Emerson presented a Kansas Department of Transportation Bureau of Local Projects Project Programming Request for Crawford County Bridge #35 near Walnut, Kansas. He explained that the State is contributing \$900,000 and the County's portion if \$86,000 and is not scheduled to be let until 2025 but the county may incur some costs next year for right of ways and utilities. Mr. Emerson stated that also included in the paperwork is an agreement between Cook, Flatt & Strobel Engineers, PA and Crawford County, Kansas for engineering services for this project. Commissioner Wood had questions on the agreement with Cook, Flatt & Strobel. The Commissioners decided to table the agreement with Cook, Flatt & Strobel and Mr. Emerson will get additional information.

Mr. Emerson explained that about 7 years ago the county agreed to fund a building fund for the new Addiction Treatment Center and it was decided that instead of transferring the money, an application for payment will be submitted to request funds. He stated that this request is for an amount of \$411,556.69 from Crossland Construction Company. Mr. Emerson requested that the Commissioners review the paperwork and will re-address on Tuesday.

**Item Five:** Mr. Emerson informed the Commissioners that there is an attorney opening for juvenile court and after the first round there was no interest in the position. He discussed the lack of attorneys in Southeast Kansas and other rural areas. He said that on the second round two applications were received and his recommendation is Ms. Candace Gayoso. Commissioner Moody stated that he knows Ms. Gayoso and the county is very fortunate have her. There was a discussion on the shortage of attorneys and the wages and rates.
